Hello,

I would like to submit my opinion on this matter:

- police service funding should be cut more than the proposed \$20M because:
- -- some social service calls can be handled by social services, freeing up officers to handle criminal matters
- -- almost everything related to traffic enforcement should be moved to a different agency that does not require sworn officers (obvious exceptions: check stops, pursuit of criminal cases, etc.)
- -- police officers should minimize dealing with non-criminal public complaints in the stations to give them more time for public presence. Auxiliary cadets used to do that much better and cheaper than officers until the police union put an end to that in the name of maximizing work for their members. This is expected from a union, but it is expected that city management represents the taxpayers and holds against that.
- -- there needs to be much more civilian oversight of the CPS. The CPS has proven to be unable to address the known issues of bias against female officers, non-white officers, and non-heterosexual officers. A civilian management team needs to be installed. The head of CPS should be a civilian; the chief of police can be the COO.
- -- unlike some aldermen claim, statistics of violent claim do not support their notion that Calgary is becoming more dangerous to live in by the month. Property crime is another matter, and perhaps a special unit of the force should be formed to address that. At this point, it seems that it costs us taxpayer more to pay for the CPS than pay for the damage from property crime. There is no cost-benefit to pay so much for a CPS that affects property crime so little.



The stresses of what they have to deal with, not just the physical danger, but also the human misery takes a toll over the months and years and decades of their job. A critical aspect of police work in the field is making good decisions that are beneficial to the safety of public. Unfortunately, approximately 30% of police officers suffer from PTSD which has an impact on decision making brain function among police. A recent preliminary study which recorded EEG tracings compared the decision-making abilities between officers having higher levels of PTSD with those that were determined to exhibit lower or no PTSD levels. Results suggested that officers with higher levels of PTSD had greater brain activation in areas related to rapid decision making. Disruptions in rapid decision making by an officer w
