Modernized Municipal Government

Focus: Pivoting our Municipal Government in a Digital Age

Potential outline for Strategic Meeting

1. Level Setting

- Importance of connectivity online, access to technology and data
- Technology as a strategic pillar to support municipal services, businesses and the citizens of Calgary

2. Discussion of Administration's work and progress to date and lessons learned

- Resilience during COVID-19 by leveraging technology
- Gaps in digital literacy (tools, access, knowledge) in our community
- Examples of how Calgary is already connected (current state), infrastructure ecosystems etc.
- Opportunities to springboard, room for improvement, and innovation challenges

3. Supporting Council in decision making

- Role of municipal government and Council leadership to bridge gaps of digital literacy
- Calgary's reputation as technology center
- Council's vision for technology driven government
- Market strategies, attracting entrepreneurs



Economic diversification

Focus: Forward thinking to increase economic resilience

Potential outline for Strategic Meeting

1. Level Setting

- Economic diversification plays a critical role in ensuring the resilience of an economy
- Variety of industries, relationships and their interdependencies influence The City's ability to respond effectively to a volatile economy

2. Discussion of Calgary's performance and comparison with peers regarding three components of economic resilience

- Resistance ability to bounce back
- Adaptability take over the shock and recover to a former state
- Reorientation structural systemic change and restore to a new, better and higher standard

3. The role for The City and City Council

- Local case studies to provide feedback about importance of local government policies
- Council direction on priority of types of economic diversification (i.e. variety-based, quality-based, or output-based)



Equity, Social Wellbeing and Inclusion Focus: Equitable and Inclusive Decision Making

Potential outline for Strategic Meeting

1. Level Setting:

- Definition of equity and inclusion
- Important aspects that are included (e.g.: anti-racism, environmental equity, Truth
 & Reconciliation, gender-equity, accessibility, affordability, etc.);
- Council's existing policy commitments related to equity and inclusion; and
- Current state and future trends regarding inequity in Calgary.

2. Discussion on Administration's work and progress to date to advance equity and inclusion

3. Supporting Council's Equitable and Inclusive Decisions

- Actions Council can take to advance equitable decision making (e.g.: in investments, in planning, in governance systems, in data collection and analysis, in public engagement, in service delivery, etc.)
- What support does Council require to inform equitable decision making?


Focus: Building a Climate Resilient City
