#### BYLAW NUMBER 59M2021

## BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 26M2020, THE TEMPORARY COVID-19 FACE COVERINGS BYLAW

**WHEREAS** Council considers it necessary to amend Bylaw 26M2020, the Temporary COVID-19 Face Coverings Bylaw;

# NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. Bylaw 26M2020, the Temporary COVID-19 Face Coverings Bylaw, as amended, is hereby further amended.
- 2. The following is added after section 9 as section 10:

#### "<u>REPEAL</u>

- 10. This bylaw ceases to be in force on July 5, 2021."
- 3. This Bylaw comes into force on the day it is passed.
