BYLAW NUMBER 59M2021

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 26M2020, THE TEMPORARY COVID-19 FACE COVERINGS BYLAW *****

WHEREAS Council considers it necessary to amend Bylaw 26M2020, the Temporary COVID-19 Face Coverings Bylaw;

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

1. Bylaw 26M2020, the Temporary COVID-19 Face Coverings Bylaw, as amended, is hereby further amended.
2. The following is added after section 9 as section 10:

“REPEAL

10. This bylaw ceases to be in force on July 5, 2021.”
3. This Bylaw comes into force on the day it is passed.
