## **BYLAW NUMBER 2H2024**

## BEING A BYLAW OF THE CITY OF CALGARY TO REPEAL BYLAW 1H2023, THE SINGLE-USE ITEMS CHARTER BYLAW

**WHEREAS** Council has considered C2024-0187, and deems it necessary to repeal Bylaw 1H2023, the Single-Use Items Charter Bylaw, which was passed pursuant to section 4(2) of the *City of Calgary Charter, 2018 Regulation,* AR 40/2018 ("Charter");

**AND WHEREAS** pursuant to section 9(1) of the Charter, Bylaw 1H2023 was passed after;

- (a) the bylaw was advertised;
- (b) the petition period expired; and
- (c) a public hearing was held;

**AND WHEREAS** pursuant to section 191(2) of the *Municipal Government Act*, RSA 2000, c. M-26 (the "Act"), the repeal of a bylaw must be made in the same way as the original bylaw is passed;

**AND WHEREAS** this repealing Bylaw has been advertised in accordance with section 606 of the Act, and 60 days have passed since the last date on which the bylaw was advertised in accordance with section 231(4) of the Act, and a public hearing has been held in accordance with section 216.4 of the Act;

# NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

#### Repeal

1. Bylaw 1H2023, the Single-Use Items Charter Bylaw, is hereby repealed.

#### **Coming into Force**

2. This Bylaw comes into force on the day it is passed.

Mayor and Members of Council,

On January 30, 2024, Council directed Administration to:

- 1. Advertise and bring forward the Bylaw for a public hearing to consider its repeal;
- 2. Develop a clear evaluation framework for collecting and reporting on the strategy;
- Develop waste management infrastructure and communication for diversion options:
   a. Focus of single-use items alternative waste management options accessibility of blue and green bins in city spaces; and
- 4. Provide a report to Council no later than March 31, 2024.

The process to repeal The Single-Use Items bylaw has several steps. One legislated requirement is to have the proposed bylaw and any document relating to it publicly available for inspection. This includes the report that will accompany the repeal bylaw for the 2024, May 7 Public Hearing of Council (attached for reference). To summarize the report, Administration is recommending that Council consider giving three readings to Bylaw 2H2024 to repeal The Single-Use Items Charter Bylaw. The report also outlines the process for public submissions and the options available to Council in considering the repealing bylaw.

## Bylaw 2H2024 – To Repeal The Single-Use Items Charter Bylaw (1H2023)

## PURPOSE

This report seeks Council's direction on Bylaw 2H2024 – to repeal The Single Use Items Charter Bylaw (1H2023).

## PREVIOUS COUNCIL DIRECTION

On 2024 January 30, Council directed Administration to:

- 1. Advertise and bring forward the Bylaw for a public hearing to consider its repeal;
- 2. Develop a clear evaluation framework for collecting and reporting on the strategy;
- 3. Develop waste management infrastructure and communication for diversion options:

a. Focus of single-use items alternative waste management options – accessibility of blue and green bins in city spaces; and

4. Provide a report to Council no later than March 31, 2024.

## **RECOMMENDATION(S):**

That Council consider giving three readings to Bylaw 2H2024, to repeal The Single-Use Items Charter Bylaw (1H2023).

## HIGHLIGHTS

On 2023 January 17, Council gave three readings to Bylaw 1H2023, the Single-Use Items Charter Bylaw. The bylaw came into effect on 2024 January 16. On 2024 January 30, Council directed Administration to advertise and bring forward a new bylaw for a public hearing to consider the Single-Use Items Charter Bylaw's repeal.

## DISCUSSION

#### Process to Repeal Bylaw 1H2023

To repeal Bylaw 1H2023, the Single-Use Items Charter Bylaw, the required two consecutive weeks of advertising for the repealing bylaw was completed with the notice of public hearing on 2024 May 07 published twice in both the Calgary Sun and Calgary Herald between 2024 February 13 and 2024 February 22.

Following the last day of advertising a 60-day petition period begins, during which a member of the public may submit a petition for a vote of the electors to determine whether the repealing bylaw be passed.

Additionally, prior to the public hearing, members of the public may submit a letter, public opinion poll or other written communication concerning the merits of the proposed repeal of the bylaw to the City Clerk.

If the repealing bylaw is enacted, the Single-Use Items Charter Bylaw will be repealed.

• If the repealing bylaw is enacted Council could direct Administration to prepare a new bylaw that considers the challenging aspects of the previous Single-Use Items Charter Bylaw and report back, on a timeline to be determined, with a revised bylaw.

If the repealing bylaw is defeated, Bylaw 1H2023, the Single-Use Items Charter Bylaw remains in effect.

 Council could then direct Administration to bring amendments to the current bylaw that offer a better balance of convenience and impact. Amending the current bylaw would then require Administration to undertake the advertisement, 60-day petition period and public hearing process for the amendments.

#### **Additional Information**

During Council's discussion in January there was an interest to understand the different components of the bylaw. The bylaw included two groupings of single-use items, shopping bags and foodware accessories, as illustrated in the following table:
