### **REASON(S) FOR RECOMMENDATION:**

Concurrently with a recent amendment to the Rocky Ridge ASP, the original black and white copy of Map 2 - Land Use and Transportation was replaced with a new colour map. This transition resulted in a number of inaccuracies on this map. This proposed amendment to the Rocky Ridge Area Structure Plan (ASP) will fix these inaccuracies and bring Map 2 of the Rocky Ridge ASP into conformity.

# **PLANNING EVALUATION**

#### **LEGISLATION & POLICY**

The Rocky Ridge ASP was last amended by Council on 2017 September 11 (Bylaw 54P2017). At that time, Map 2 – Land Use and Transportation was revised to accommodate a land use redesignation proposed in the community of Rocky Ridge (Bylaw 299D2017).

As the original black and white edition of Map 2 was challenging to interpret, the recently approved Bylaw 54P2017 included an updated colour version of this map. Through this transition from black and white to colour various inaccuracies occurred (e.g. misallocation of various land use typologies).

The intent of the report is to replace the current Map 2 of the ASP with a revised Map 2 that will allow for all individual land use areas and typologies be accurately reflected in the Rocky Ridge ASP.
