Getting to Quality Development

Over the past year, Planning & Development (PD) has made some foundational changes to enable a greater focus on realizing high quality development in the city. This includes a renewed focus on urban design review, changes to staff resourcing and organizational structure to integrate urban design specialists within Community Planning, and process changes to enable early engagement with the Urban Design Review Panel (UDRP) and Calgary Planning Commission (CPC). These changes have set the groundwork for continued improvements over the next year. The chart below provides details on the work completed to date, as well as details of additional work currently underway.
