# Supporting Policy


- As Per City of Calgary Traffic Calming Policy:
  - Alleys. Speeding and short-cutting can be issues in some alleys, usually as a result of
    congestion on nearby roads or commercial traffic. The City responds to speeding and
    short-cutting issues in alleys by installing modified speed humps designed for use in
    alleys, and with other solutions such as one-way operation or access restrictions as
    appropriate.
- Municipal Development Plan, 3.4.3 Neighbourhood Corridors
  - Auto-oriented uses and designs that generate high volumes of traffic and create negative impacts for pedestrian travel and access should be discouraged. We support incorporating a pedestrian pathway to the escarpment at the south end of the parcel and restricting lane traffic.
- Community Standards Bylaw 5M2004, To Regulate Neighbourhood Nuisance, Safety & Livability
  - "Lane" means an alley **intended primarily for access to the rear of premises**located adjacent to the alley

#### **Brief History**

Britannia Drive is a 10.4 m wide "collector" standard road that abruptly ends approximately 50 m south of 49 Avenue S.W. and west of 919 49 Avenue SW (the Reinhart property). It is believed that Britannia Drive was originally planned to connect to 50 Avenue SW. A Trans Alta Utilities high voltage tower is located at the south end of Britannia Drive as seen in photo 1. The area west of the Reinhart's is a dog off-leash area and is used regularly by dog walkers and joggers.

Mr. & Mrs. Reinhart contacted The City almost three years ago regarding traffic on the portion of Britannia Drive immediately west of their house at 919 49 Avenue SW. Many issues were identified over the years including traffic parking on Britannia Drive, shortcutting on the alley south of the Reinharts which connects to Britannia Drive, young people congregating on weekend evenings, excess traffic, noise etc. The Reinharts indicated the Trans Alta tower has been hit by cars on more than one occasion. The two key issues identified this month by Mr. Reinhart are:

- 1. Providing protection for the Trans Alta Utilities tower located at the south end of Britannia Drive.
- 2. High speeds of southbound traffic on the portion of Britannia Drive west of his house.

#### **Traffic Counts**

Traffic counts were originally completed on a weekend in December 1998 and found to be 30 vehicles per day in the alley and 40 vehicles per day on Britannia Drive. Mr Reinhart indicated traffic was far worse during summer months so volume and speed counts were completed on a weekend in July 2001. Volumes were found to be 35 vehicles per day in the alley and 80 vehicles per day on Britannia Drive. 85 percentile speed in the alley was found to be 30 km/h; on Britannia Drive, 30 km/h northbound and 41km/h southbound. Speed counts were taken approximately 10 m south of 49 Ave SW. The southbound speed on Britannia Drive is somewhat high considering the road is essentially a cul-de-sac.

#### Recommendation

1. Erect a guard rail on the north side of the Trans Alta Utilities tower to protect against a collision.

2. Erect two New Jersey type barriers, one with a "sharp curve" warning sign at the south end of the Britannia Drive "cul-de-sac" as shown on Map B (Signage subject to review by Traffic Assessment Division). Use the two barriers to narrow the throat of the "cul-de-sac" from 10.2 m to 5.0 m. The short section of Britannia Drive could still operate as a two-way road. This installation is temporary only, evaluated over a one year period, then assessed.

#### Notes:

- Request installation as soon as possible since protection of the tower is a safety issue.
- New Jersey or similar barriers should be "clean" since located in a residential area.
- Recommend "NEW" signs be installed when barriers installed since some habitual users will not expect a change.

#### Subject: Alley/Lane - South of 49th Avenue SW between 8th Street SW and Britannia Drive SW

For over 20 years, we have been communicating with various Departments and Representatives of the City of Calgary about significant safety and security concerns/issues on this laneway due to short-cutting and the inappropriate use of this lane. These concerns/issues include:

- Frequent use of the lane as a road to connect from Britannia Drive to 8<sup>th</sup> Street SW by vehicles travelling both east and west, instead of using 49<sup>th</sup> Avenue SW;
- Speeding significantly in excess of 15K in the lane, which endangers those walking in the lane or vehicles coming from the other direction;
- Traffic volumes well in excess of the norm;
- Significant dust, dirt and stones being kicked-up;
- Use as an all-day destination location for objectionable behavioral activities including public urination, sex, drugs, booze, partying, garbage, etc., which is a safety concern for residents of Britannia;
- Multiple accidents (speeding which resulted in crash into fence and electrical tower, car crash through barrier east to west and over cliff, car speeding hit corner or our fence, crash into our neighbour's fence, crash into signs at 49<sup>th</sup> Avenue & Britannia Drive beside parking area)
- Ongoing privacy, security, parking and noise concerns such as sleeping overnight in car in lane, cars set on fire in lane, stolen cars left in lane.

A brief summary of interactions with the City pertaining to this issue follows:

- (1991-1992) Initiation/ongoing discussions with Transportation Department regarding lane issues and proposed mitigation actions;
- (1994) Discussions with the City Land and Housing and Corporate Properties to consider sale and consolidation of a portion of lane;
- (1994-2000) Ongoing discussions with Corporate Properties, Alderman, TransAlta, Transportation Planning, Roads, Traffic Safety, Parking regarding noted issues and opportunities for improvements;

- (2001) Traffic and speed counts on the lane along with the acknowledgement of other significant "behavioral" issues gave rise to the City proposal (The Plan) to effectively convert a portion of the road to alley width;
- (2002) Project completed (road changed to alley width);
- (2002-2014) As agreed, ongoing monitoring, feedback and communication with the City re success/failure of the Plan as implemented;
- (2014-2016) Multiple communications with the City concerning the ongoing lane issues and requests for needed further discussions.
- June 30, 2016 Submitted a request through 311 regarding traffic study for the constant short-cutting in this lane. The website indicates that the status is closed. No one has reached out to us to tell us that the status is closed or if any action has been taken in this regard.

As indicated above, some measures were taken in 2002 to alleviate the documented concerns. The attached letter from Roads to Transportation Planning indicated 35 vehicles per day in the alley and 80 vehicles per day on Britannia Drive SW. Speed was found to be 30 km/h northbound and 41 km/h southbound. It is not clear to us on the appropriate volume of vehicular traffic in an alley, but this measurement was taken on a weekend in July 2001 when it was raining.

The result of this investigation in 2001 was a road width reduction on the south end of Britannia Drive SW and visual deterrent/directional signs posted that indicate a left turn onto 49<sup>th</sup> Avenue SW from southbound Britannia Drive. These measures were undertaken with the expectation that ongoing monitoring and feedback would serve as an indication of a need for more comprehensive action. This included the greening of the road that was portioned off to create a visual barrier of parkland, which has never occurred and now is a complete eyesore with weeds growing around each post and in the cracks in the road.

As a result of the increasing densification of the inner city and the increased use of the off-leash area, the volume of usage of this particular area has amplified to a point that it continuously impacts our quality of life, our privacy and the usage of our property. It also impacts the quality of life of our neighbours whose backyards sit adjacent to this lane. Our safety, and the safety of park users, has been compromised routinely by individuals wishing to use the area to do drug deals, take drugs, have sex, play loud music, drink, urinate, etc. We feel that we constantly have to monitor activities around our house, our neighbours' houses, and the community area in general, as opposed to enjoying our privacy. Attached is a partial log of documented concerns dating back to 2009.

These concerns certainly continue today, but with heightened regularity. The increase in traffic is substantiated by the City of Calgary Main Streets initiative which indicates that traffic has increased from 5,000 vehicles per day in 2000 to 8,000 vehicles per day in 2013 in the area. And as the City has allowed parking relaxations on the commercial developments on three corners of 50<sup>th</sup> Avenue & Elbow Drive SW, more pressure has been exerted on the adjacent communities, thereby increasing vehicular traffic in Britannia Plaza and the surrounding area. It appears that drivers are avoiding the four-way stop intersection at 49<sup>th</sup> Avenue & 8<sup>th</sup> Street SW and simply using the lane as a road.

It is our understanding that alleys are 'intended chiefly to give access to the rear of buildings and parcels of land' as per By-Law #26M96. This By-Law also indicates that speeds shall not exceed 15 kms/hour. There is one garage on the lane in question for the homes on 49<sup>th</sup> Avenue SW. By far, the majority of vehicles using the lane are not accessing the homes but are cutting through and many are speeding while kicking up gravel and dust.

According to the Transportation Action Plan 2015-2018, the Transportation Department commits to ensuring customers feel safe while using the transportation system and that it will 'keep communities safe by meeting and maintaining standard for crime prevention, fire response and enforcement'. This includes conducting community traffic studies that investigate short-cutting. In addition, the 2015-2018 Action Plan, A City of Inspiring Neighbourhoods, states that 'every Calgarian lives in a safe, mixed and just neighborhood'. The Strategic Actions within this plan indicate that a key area of focus is to support initiatives to reduce traffic speed in neighbourhoods.

In addition, the 50<sup>th</sup> Avenue SW Area Redevelopment Plan (ARP) does not include the parcel of greenspace that runs between the lane and the Calgary Golf & Country Club. According to this ARP, "the lands encumbered by the overhead transmission line act as a major connection to this system by tying the river valley landscape to green spaces further inland. Future proposals of this corridor will need to ensure that this connection is maintained". The ARP further identifies this site as a "Pedestrian and Cycling Friendly Linkage". So while this site is not included in the ARP, there is direction within the ARP as to what is proposed to occur on this site. The current usage of this lane prevents this connection and is certainly not pedestrian or cycling friendly.

In conclusion, the lane is being used as a street. It is not, nor was it ever intended to be another street, but rather, to only be used as intended and allowed. The City of Calgary Municipal Development plan indicates that the City of Calgary will create a city attractive to people and create a city that provides a 'qood quality of life'. This is certainly not possible considering the usage of this lane.

Therefore, we formally request that the City of Calgary take some action to find a resolution to this ongoing situation. In consideration of the City's Main Streets initiative, and the proposed connectivity of the corridor, this green space presents an opportunity for beautification and improved usage. However, that cannot happen safely with the current and continued usage of this lane by vehicular traffic.

We request a contact at the City of Calgary Transportation Department who will listen to our concerns and implement actions which including, but not limited to:

- Closure of the lane
- One-way lane
- Improved signage and enforcement
- Gates at each end that allow access for City service vehicles only.

All of these initiatives can be achieved in conjunction with the development of a pedestrian/cyclist connection that supports the City's plans and the 50<sup>th</sup> Avenue ARP. We look forward to your response and recommended solutions.



I support the Certus parking lot development on 8 Street and 50 Avenue SW.

My name is Donita Beaulieu and I am a small business owner of Ginger Laurier, a women's boutique store located at 812 – 49 Avenue in the Britannia Shopping Plaza. My store has been open for business in this shopping plaza since 2012.

My customers have been experiencing difficulty finding available parking when they are shopping at the Britannia Shopping Plaza since the completion of the Ghitter Block located on the corner of Elbow Drive and 49 Avenue SW. Traffic has increased since the businesses in the Ghitter Block started opening in August 2017. We also note increased traffic due to the opening of the Britannia Medical Clinic in the shopping plaza this past summer.

I have kept a daily account of customer complaints about the shortage of parking and noted 30% of customers entering Ginger Laurier comment they have had difficulty finding parking. Limited parking happens during peak hours of 11 to 2pm and 4 to 5:30pm.

My customers fall into three categories:

- 1. Age 25 40 year old women
- 2. Age 40 55 year old women
- 3. Age 55 70 year old women

Families with younger children and older women with physical limitations find the limited parking especially difficult.

Many of the customers who come into the plaza patronize several stores. They typically buy groceries, bank, go for lunch, shop for kitchen accessories, and buy supplies for their pets. In the past several months customers have mentioned they sometimes are unable to park so do not stop to shop.

As a small business retailer I want my customers to have a positive shopping experience and am grateful they shop local! Offering additional parking would be encouraging and welcoming to all.







The newly merged Elboya and Britannia Community Association is asking for your input into the parking situation around the Plaza. We know that the busy Christmas season is important to your businesses and are asking you to document any issues during this period.

#### **Background:**

- The City has recently allowed a significant number of parking relaxations when approving new developments or change of use of Plaza tenants.
- These include relaxations for the Opus building, the new Certus building, the medical clinic (formerly the children's wear shop), and others.
- City Policy supports more densified, less car dependent redevelopment of older neighbourhoods.
- Parking requirements for commercial uses are determined by a formula that specifies the number of stalls required based on the area of the space occupied and its specific use (e.g. office, medical, retail, grocery, restaurant, bank etc.).
- Relaxations are a reduction in the number of stalls that the developer is required to provide, based on factors such as available street parking, whether a residential parking zone bylaw is in place (it is), access to public transit (i.e. the Number 3 bus), and the nature of the uses (e.g. evening restaurant patrons and day time bank patrons can use the same stalls).
- A formal parking study may be conducted to support a request for relaxations, but typically these studies measure average demand, not necessarily peak demand such as over the Christmas rush.

Certus Developments has made an application to the City of Calgary to develop a section of the grassed area under the transmission lines, just west of 8th Street SW and north of 50th Ave. The development would be for a surface parking lot, providing about 56 stalls to patrons and employees of the surrounding businesses. This application was recommended for refusal by City Administration and the Calgary Planning Commission, but it will go before City Council for a decision in January and we would like your help in identifying the need, if any, for this parking lot.



# Appendix:

## A Development Time Line for Britannia and Elboya Heights

- 1910 Elboya and Britannia annexed by the City with 50<sup>th</sup> Ave SW the City Limits. Subsequently planned for subdivision but not developed.
- 1947 Leduc Oil Delivery
- Late 40s to mid 50s Elboya and Britannia built out as a "complete" neighbourhood with commercial, diverse housing, recreational and natural parks, schools and places of worship.
- 1960s Community Associations established
- Early to mid-2000s 2 gas stations closed near Elbow and 5<sup>th</sup> Ave, and remediation started.
- 2006 Plan-It Calgary: Integrated Transportation and Municipal Development Plan calls for modest densification in Established Areas, with an emphasis on Neighbourhood Activity Centres and Corridors to be supported by a local area planning process.
- 2007 Homes by Avi comes forward with an aggressive plan to develop Alta Link lands on the north side of 50th with multifamily. No meaningful community consultation occurred resulting in aggressive push-back. Project remains dormant.
- 2008 Application to consolidate 5 single family lots on Elbow Dr. for a 31-unit multi-family development. Community objects, project was abandoned, and property flipped.
- 2010 Elboya, Britannia and Windsor Park, through the Federation of Calgary Communities, initiated a community-driven planning process with student groups from U of C's faculty of Environmental Design. It was very successful and 3 innovative "plans" were presented this diffused the knee-jerk negative reaction to area redevelopment and helped the residents in the three communities accept that development was happening and that it could be influenced to improve the area.
- 2010 A small slab strip development is proposed under the exiting land use for the former gas station site on the SW corner of Elbow and 50<sup>th</sup>. The City "encourages" a more aggressive development and an application for the mixed-use office and commercial Opus building comes forward with a requirement for parking relaxations. The communities object to R-C1 rezoning, building scale and potential parking/traffic issues.
- 2010 The City of Calgary's Heritage Planner commissions a Statement of Significance (completion of the Historic Resource Evaluation Form) for the Community of Britannia. http://calgaryarea.com/content/communities/britannia/documents/britannia-statement-historical-significance.pdf
- 2011 Miliken Developments presents plans for an 80-bed Memory Care Facility. Subsequently built and successfully integrated into community with minimal parking impact.

### Development Time Line continued

- 2009-2011 An extensive plan for the Design and Development of River Park, Stanley Park and Britannia Slopes is undertaken and approved with funding and implementation in 2014-17. The plan emphasizes that community stewardship opportunities be offered. A pathway project could be away of engaging residents. http://www.calgary.ca/CSPS/Parks/Pages/Construction/River-Park-Sandy-Beach-and-Britannia-Slopes.aspx
- 2012 Alderman Pincott initiates the 50<sup>th</sup> Ave SW Area Redevelopment Plan in response to community concerns with aggressive development and the need for a comprehensive plan to guide redevelopment.
- 2012 The Opus Building is approved, and construction starts but is slow to lease, partly because of insufficient parking. Subsequent change of use applications (e.g. a day care) require more parking relaxations.
- 2013 An application comes forward for the Windsor, a large mixed-use office/commercial building on the SE corner of Elbow and 50<sup>th</sup> Ave, site of a former convenience store, dry cleaner and clinic. An extensive community consultation process occurs, and the planners promise that they would not seek parking relaxations. The community concedes to a larger building in exchange for developer support for the 50<sup>th</sup> Ave ARP. The 2-level underground parking garage is constructed, then building is suspended.
- 2013 50<sup>th</sup> Ave. ARP is adopted with no opposition from any community member. Alta-Link objects as the major landholder but was chastised by Council for not participating in the planning process. The ARP details where redevelopment is to occur, what scale, it includes reference to preserving community character and creating green connections to the Elbow River natural area. http://www.calgary.ca/PDA/pd/Documents/arp-asp/arp/fifty-ave-arp.pdf
- 2014-15 50<sup>th</sup> Ave SW is included in the corridor studies for the Main Streets program. http://www.calgary.ca/PDA/pd/Documents/main-streets/what-weve-learned/50AvSW.pdf
- 2016 Certus development proposes a new, 2-story building at the east end of the Britannia Plaza (former gas station site) under the existing land use. The application requires about 50 parking relaxations. Building is subsequently constructed.
- 2016 A BEW parking zone bylaw is implemented, mainly to address residential parking on Windsor Cres due to the opening of the Opus Building and specifically Brown's Social House.
- 2016-2018 parking pressures in the communities and around the Plaza continue to mount. Additional relaxations are granted for a medical clinic and coffee shop expansion in the Plaza, as well as a new coffee shop in the Ghitter Block. Certus Developments proposes a parking lot to make up for the relaxations granted.
- 2017 The Windsor switches from office to residential condos above the commercial floor in response to market demand.
- 2017 Elboya and Britannia Community Associations merge.

This submission opposes a land use amendment application to be heard by Council on February 20, 2018. The applicant for the amendment requests discretionary use for a surface parking lot in Britannia (Ward 11) at 8<sup>th</sup> Street SW & 50<sup>th</sup> Avenue SW.

I am the owner of the six unit apartment building at 903 49 Avenue SW which is immediately adjacent to and directly north of the proposed surface parking lot. I am out of town for the Council Meeting Hearing and ask Council to consider this submission in its deliberations.

I oppose the application and respectfully submit there are three reasons why the application should be declined.

1. It is premature to permit any application for a surface parking lot.

At the December 14, 2017 Planning Commission hearing, the applicant declined to provide an updated parking study. However, much has changed since the last parking study was done in 2016.

The need for additional parking cannot be determined until the Windsor building construction is complete on the SE corner of Elbow Drive & 50<sup>th</sup> Avenue. The office component of the original Windsor development has now largely been replaced with multi-family residential which will create an estimated surplus of 54 underground parking stalls in excess of the needs of that building.

A new parking study must consider not only the additional parking provided by the Windsor development but also the impact of all other major changes to parking needs over the past two years. If a new study determines additional parking is required, every effort must be made to generate and examine alternatives to permitting a surface parking lot to be located on the prime green space leading to the Britannia escarpment as contemplated by the existing application.

There needs to be a better understanding of alternatives such as allowing parallel parking on 50<sup>th</sup> Avenue east of Elbow Drive, increasing utilization of the under-utilized 120 stalls behind the Sunterra building (perhaps through some sort of sub-lease), the possibility of using part of the utility corridor directly east of the existing McInnes & Holloway paved parking lot that is adjacent to 50<sup>th</sup> Avenue SW. or possible changes to parking rules on the City owned parking in the middle of the Britannia Shopping Centre.

A new parking study is needed to support the applicant's position that there is increased demand for parking that justifies a surface parking lot on prime green space that is an entrance to the Britannia escarpment. We also need a business case to be made for why this is the only alternative.

2. The application should be declined because the economics do not justify construction of a surface parking lot to a high enough standard to justify using prime green space that is an entrance to the Britannia escarpment.

The applicant made it clear at the December 14, 2017 Planning Commission hearing that the economic business case for a surface parking lot is marginal at best. The economics will not permit pavement of the parking lot and a five-year permitted use is not sufficient to allow the applicant to recover costs and provide a reasonable return. Rather than a "temporary" permitted use, what is really being proposed is a long term permitted use contrary to existing City policy.

Given the marginal economics of the project, the applicant will want to make efforts to lower overall costs and maximize revenues. The Applicant has already stated that paving cannot be done for cost reasons although the parking lots behind Sunterra and McInnes & Holloway lots are paved and these lots are not adjacent to residences. A gravel parking lot adjacent to residences should not be allowed.

Further cost reduction efforts by the applicant could adversely impact landscaping, noise abatement measures, lighting issues and security monitoring issues. Minimal requirements such as setbacks and landscaping that may be imposed as part of the requested discretionary parking lot use are unlikely to ensure a surface parking lot that is minimally invasive to adjacent residents and aesthetically pleasing given the location's stature as a greenway to the Britannia escarpment.

It is not clear whether such a parking lot would be open 24 hours a day or what kind of parking use would be permitted but a need to increase revenue from such a marginal project could have adverse impacts on residents with higher traffic levels and nighttime and early morning noise issues. Many of these issues cannot be adequately addressed as part of the development permit application process.

3. <u>Council should decline the application for the reasons stated in the Refusal recommended to</u> the Planning Commission by the administration in their report dated December 14, 2017.

I support the Planning Commission's refusal of the application and the administration's reasons for recommending the application be refused. The reasons for the administration's refusal recommendation included the application's non-conformance with applicable City policies, the lack of current parking studies supporting a need for the surface parking lot and the applicant's non-acceptance of a five-year temporary use restriction on the lands to be used as a surface parking lot.
