Chinatown Phase 2 Work / Tomorrow's Chinatown Project

Three years ago, Chinatown and Calgary's concerned Chinese community marched on City Hall to protest the lack of consultation regarding a land use redesignation application on a large parking lot property in the community (i.e. El Condor Lands). The concern was development without a complete understanding of the design and use would dramatically impact the core of Chinatown and the affect the characteristics of Chinatown's historical and cultural community. Chinatown has been and must remain an iconic cultural community, a 'Must Visit Destination' for all visitors leaving 'Great Memorable Experiences'.

Several community stakeholders including members of the Chinatown District Business Revitalization Zone (CDBRZ) Board of Directors expressed grave concerns that this redesignation without a modern, relevant, and culturally appropriate land use design would devastate this 109-year community and Calgary's 136-year Chinese cultural heritage. There was hope for a better process and path forward to tomorrow's Chinatown before this and any future land use or development permit application could proceed.

The Chinatown Community Stakeholders' Committee (CCSC), which many members of the CDBIA Board were a member of, presented to City Planners and City Council a renewed vision for Chinatown that is,

Calgary Chinatown is an iconic place and cultural community that prides itself for its heritage, open space and Asian streetscape and architecture.

It is a most walkable, accessible and livable community a thriving authentic small-business district, an intergenerational social and community hub, and a most visited local and tourist destination. Cultural Plan for Chinatown: Tomorrow's Chinatown 2019 August 8 Page 2

Today, the Chinatown Business Improvement Area (CBIA) formerly known as the CDBRZ, wishes City Council and Administration, other community stakeholders and future collaboration participants to know that this vision statement remains relevant for "Tomorrow's Chinatown".

The CBIA stands to be counted in developing a quality, effective, and sustainable plan for Tomorrow's Chinatown.
