Festival and Event Policy

The Policy was intended to contribute to fostering:

- an exciting and vibrant range of festivals and events;
- our diverse cultural character and celebrating our living heritage;
- the growth of volunteerism;
- the growth of tourism;
- the attraction of businesses and workers interested in active communities;
- safe communities.

In support of the Policy, Council approved the Festival and Event Subsidy Program (FESP)







Festival & Event Subsidy Program

- Event Advisory Committee performs merit review of subsidy requests.
- Steering Committee made up of 14
 Business Units ensures effectiveness of the program.
- Interdepartmental Events Team is responsible for providing technical review of all applications.







2013 Highlights

2013 Highlights

- 270 events
- 134 events subsidized
- \$8,000 in City services on average
- A unique year:
 - Tour of Alberta
 - Shaw Charity Classic
 - Opera in the Village
 - sPark
- 980,000 people attended festivals and events subsidized by The City.








2013 Flood Effects

- 21 events were affected by the flood
 - 13 were cancelled outright
 - 8 were re-located or moved to another date
- Canada Day relocated and produced just 10 days after
- Prince's Island Park rehabilitated in time for Folk Fest





Festival and Event Impact

2013 Impact

Subsidized events reported:

- \$21M in revenues
- 22,449 volunteers
- 3,363 business partnerships;
- \$17M raised for charities



2014 CS&PS Citizen Expectations and Perceptions Study

- 71% of citizens rate Festivals as Important to Quality of Life
- Festivals also scored higher in 2014 on:
 - Quality of Service (72%)
 - Value for Money (59%)



Subsidy Program Review

- By 2013 there were double the number of events eligible for subsidy than in 2010
- Seeking to balance the number of events and the available funds:
 - Mitigation Strategies for 2013
 - \$300,000 Budget Adjustment
 - Program Review







New FESP Strategy

- 1. Annual Post Event Reporting
- 2. Annual Subsidy Application
- 3. Graded Subsidy
- 4. No Event Receives 100% Subsidy
