#### **EXECUTIVE SUMMARY**

At the 18 September 2019 SPC on Transportation & Transit, Committee recommended that Council consider the creation of a sub-committee of Council to review all matters related to the Green Line LRT Project as a stand-alone committee.

#### ADMINISTRATION RECOMMENDATION:

That Council recommends:

- 1. Establish a Greenline Committee of Council
- 2. Approve the Terms of Reference outlined in attachment
- 3. Direct the membership be appointed to the committee through the October 28 Organizational Meeting of Council.

#### PREVIOUS COUNCIL DIRECTION / POLICY

At the 18 2019 September SPC on Transportation & Transit Committee meeting, committee recommended that:

That the Standing Policy Committee on Transportation and Transit recommends that:

- Council Direct Administration to return with a status report, through the Standing Policy Committee on Transportation and Transit, no later than Q4 2019;
- Administration explore the option of creating one Council Committee to consider all Green Line Project-related reports and report back to Council on this matter on 2019 September 30 with a Terms of Reference; and
- 3. Council direct that the confidential presentation, advice and discussions remain confidential pursuant to Sections 16 (disclosure harmful to business interests of a third party), 17 (disclosure to personal privacy), 24 (advice from officials) and 25 (disclosure harmful to economic and other interests of a public body) of the *Freedom of Information and Protection of Privacy Act*, to be reviewed by 2029 December 01.

## **BACKGROUND**

Traditionally, seeking council approval for and reporting on matters related to the Green Line LRT Project have spanned several different committees of council, including the SPC on Transportation & Transit, The SPC on Community & Protective Services, The SPC on Planning & Urban Development, The SPC on Utilities and Corporate Services, the Priorities and Finance Committee, and Audit Committee.

### **INVESTIGATION: ALTERNATIVES AND ANALYSIS**

As the Green Line LRT Project ramps up towards construction and execution, the need to align and coordinate all related decisions is becoming more critical. To that end, establishing a subcommittee of Council that will consider all aspects of the project as a whole will be key to its success. A Terms of Reference has been developed to outline the governance model, membership and purpose of this committee (Attachment). Upon approval of this Terms of
