Principles

- Sets the path for the future planning system, including the Land Use Bylaw
- Informs future local area plans
- Develops a common policy language for built-form outcomes
- Adopted as a policy document to support Municipal Development Plan objectives

Existing Tools, Existing Conversation

- Policies based on scale and use of development
- Outdated policies, not always supportive of goals
- Unclear relationship between Municipal Development Plan, tools and outcomes
- Helicopter approach: top-down, aerial view of communities



New Tools for Great Communities

- Policies based on form and function
- Future-focused
- User-friendly documents that various audiences can understand and use
- Creates clear and understandable expectations for growth and community evolution
- Policies that clearly implement MDP vision
- People approach: designing for the experience of people in an area

Going forward – Shared Understanding & Intent

- Testing and amendments in a timely fashion
 - Living document
 - On-going testing
 - Creation of a sustainment group
- **Future Outreach and Engagement**
 - With other projects and initiatives
 - In-depth discussions and broader outreach
 - Strategic approach to minimize fatigue
 - Voluntary application testing (with potential for CPC workshops)
- Future work plan
 - Alignment of other Guidebook
 - Alignment with future deliverables Heritage, Established Areas Growth and Change Strategy



Issues - Still to be resolved

Timing of adoption

Option 1: December 16, 2019 Public Hearing of Council

- Statutory document provides authority to move forward with local area plans while still committed to testing mentioned above and report-backs through other project reports
- Allows administration to plan for future phases with more certainty

Option 2: In combination with the North Hill Multi-Community Plan

- Allows stakeholders to have more time with the document and be part of the testing before adoption
- Could reduce version control

Option 3: Non-statutory document until Q4, 2020 to allow for more testing

- Builds trust by having more stakeholders use the document prior to its official adoption
- Allows more time for other projects to catch up Heritage, Established Areas Growth and Change Strategy



Issues - Still to be resolved

Applicability of the built-form and common policies (Chapter 3)

Option 1: Applied to all built-out communities once the Guidebook is approved

- Equal application of best practices principles to all communities
- More immediate progress city-wide towards development outcomes
- Minimal education/outreach has been done

Option 2: Applied to communities as they go through a local area plan process

- Allows for education/outreach prior to application
- Ensures that built-form outcomes in areas that have a future growth plan
- Does not provide a consistent approach to achieving built-form outcomes

Option 3: In addition to Option 2, applied to communities without an existing statutory plan

- Allows for communities without existing plans to have a new plan with updated policies
- Ensures that built-form outcomes are applied in areas that have a future growth plan
- Does not erode trust with communities that have existing statutory plans
