



Public Submission Summary

Federal Legislation on Prostitution

Background

On December 20, 2013, the Supreme Court of Canada decided that three prostitution-related offences in the Criminal Code were unconstitutional. These are:

- Keeping or being in a common bawdy-house;
- Living on the avails of prostitution; and
- Communicating in public for the purpose of prostitution.

While the act of prostitution itself is not illegal, the Supreme Court of Canada found that, by making these activities illegal, the dangers that prostitutes face were increased. The Court concluded prostitutes' rights to life, liberty and security of the person — rights which are guaranteed to everyone — were being violated.

To avoid prostitution being unregulated for a period of time, the Court gave the Federal Government one year to respond. In the meantime, the three offences will continue to be enforced under the Criminal Code of Canada.

The City of Calgary Response

The Federal Government is responsible for creating the laws related to prostitution and for deciding how to respond to the Supreme Court's decision.

In February, Council approved a Notice of Motion to conduct engagement of external stakeholders through a public submission process in the wake of a recent Supreme Court of Canada ruling that opens the door to new federal legislation on prostitution.

While The City of Calgary does not know what decision Parliament will make, City Council recognizes that prostitution has impacts and Council would like to better understand Calgarians' views about the current impacts of prostitution on communities, families and businesses.

It is important to note the following key points when reviewing results highlighted in the subsequent report:

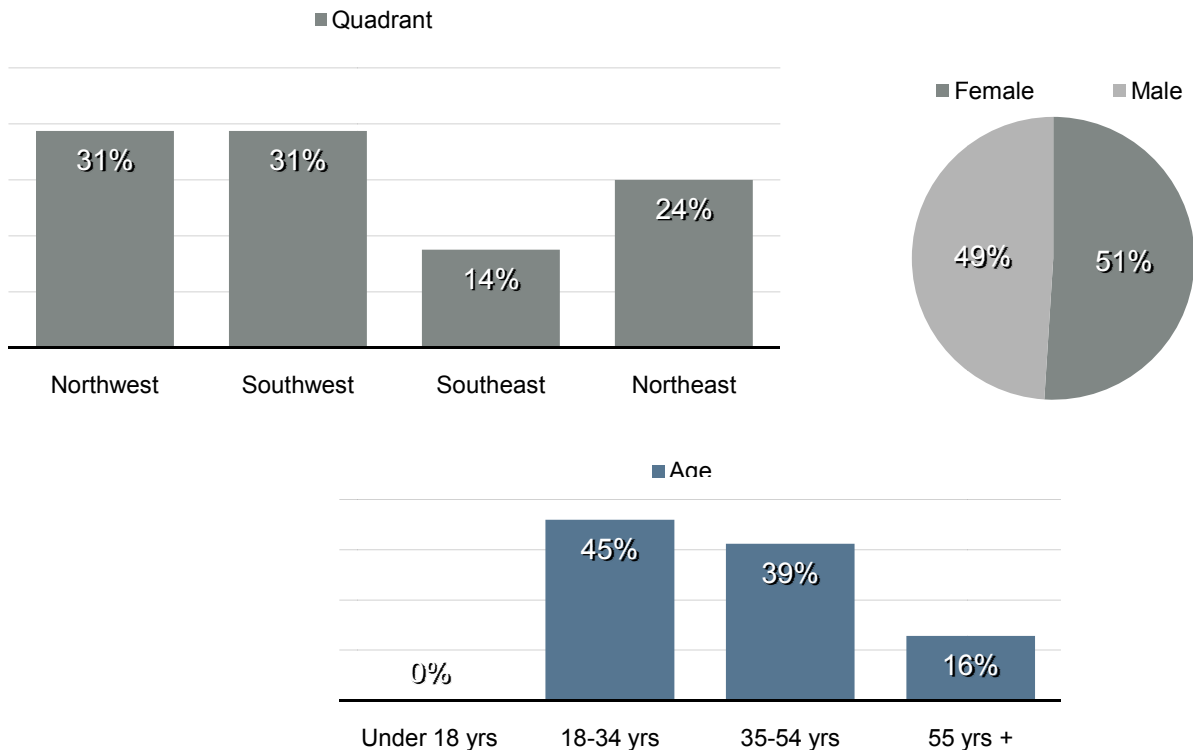
- This engagement exercise was requested by Calgary City Council and was designed in collaboration with City Administration. The core purpose was to solicit feedback from stakeholders about the issues outlined in the subsequent report.
- Feedback for each option was provided on a self-selected basis by stakeholders during the two-week engagement process. As such, broader conclusions regarding the general attitudes of the public as a whole should not be made.

Results Summary

In total, there were 1,861 visits to the submission website and 797 individuals/stakeholders completed the entire submission document. The average completion time was just over 36 minutes in total. It is important to note that the base sizes for each question varies, as respondents did not need to provide a response to each before moving onto the next screen.

Submission Respondent Profile

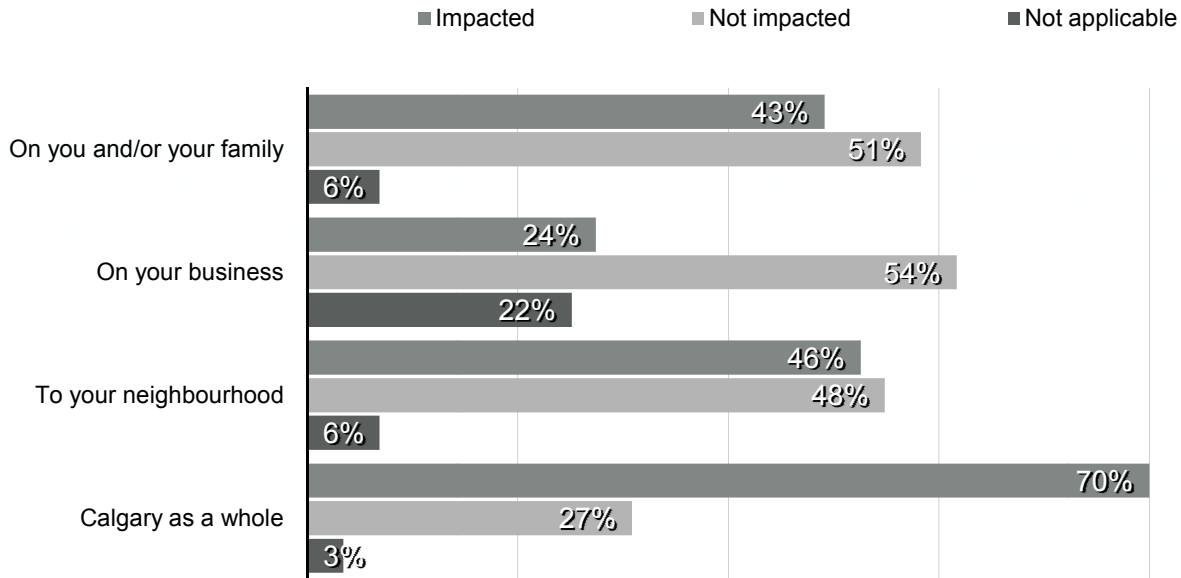
The following are demographics across the submissions - it is important to note that these were not mandatory questions and may not fully represent the range of those who completed the submission form.



Impacts of Prostitution

In an effort to better understand the views about the perceived impacts of prostitution in Calgary, respondents were asked to provide an open-ended response to each of the four categories below OR to select not impacted or not applicable.

Almost half of respondents (43%) feel prostitution has impacted them personally and the majority (70%) say they believe prostitution does have impacts to Calgary as a whole. Just less than one-quarter (24%) say their business has been, or is, impacted by prostitution while just under half (46%) say their neighbourhood was/is impacted.



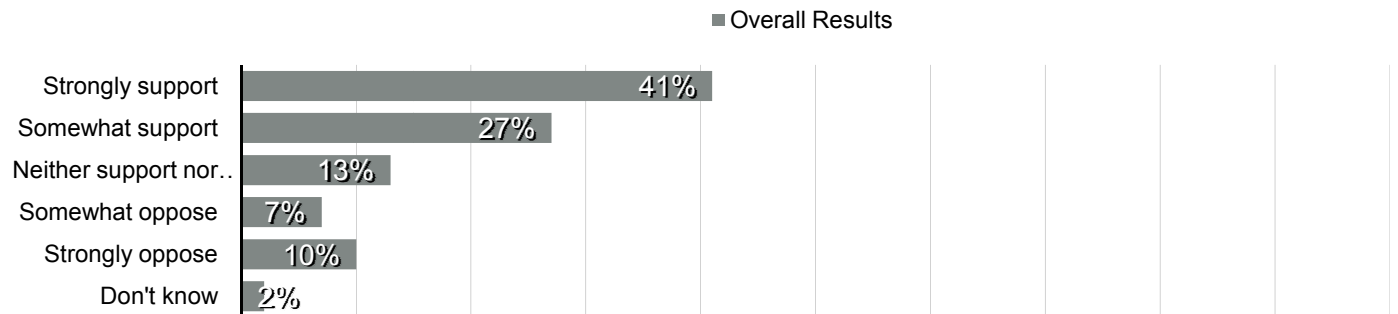
Support for Approaches

Respondents were asked to give feedback on various approaches are used by other cities to increase the health and safety of those affected by prostitution.

Question: Please indicate how strongly you support or oppose the following approaches used.

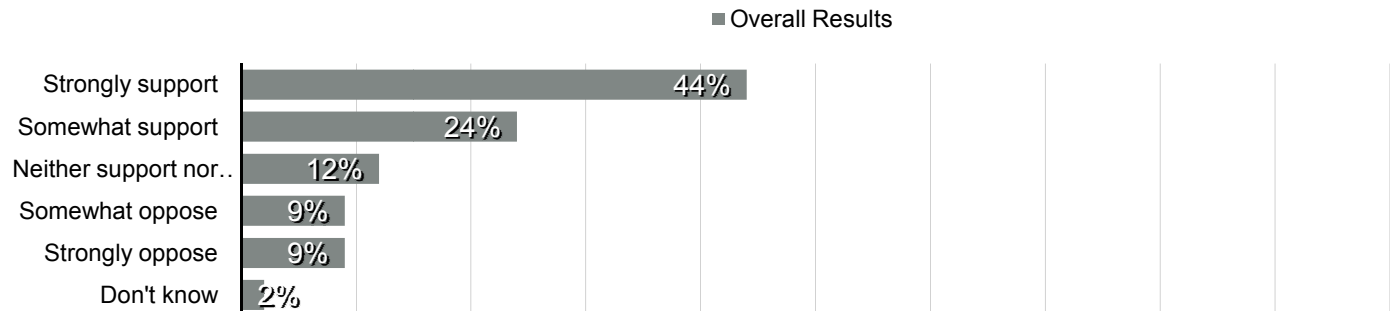
Approach #1: Research and Ongoing Building of Knowledge Approach

This approach helps governments and non-profit organizations understand prostitution and learn the most effective ways to protect the health and safety of all Calgarians. Examples could include supporting partnerships between community organizations and universities to learn how to increase the health and safety of all of our community members.



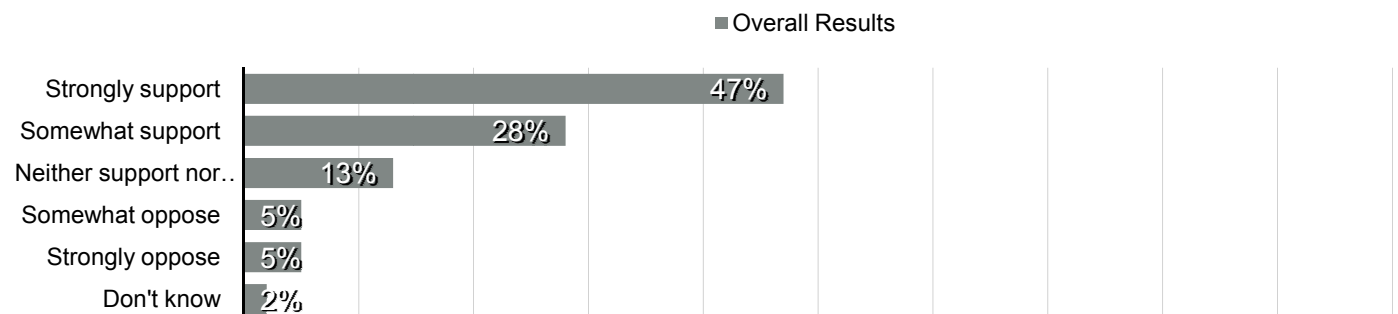
Approach #2: Exiting Approach

This approach focuses on assisting individuals in leaving prostitution once they are ready to do so. Examples could include programs to help workers leave prostitution, such as education and life skills development, and employment counseling.



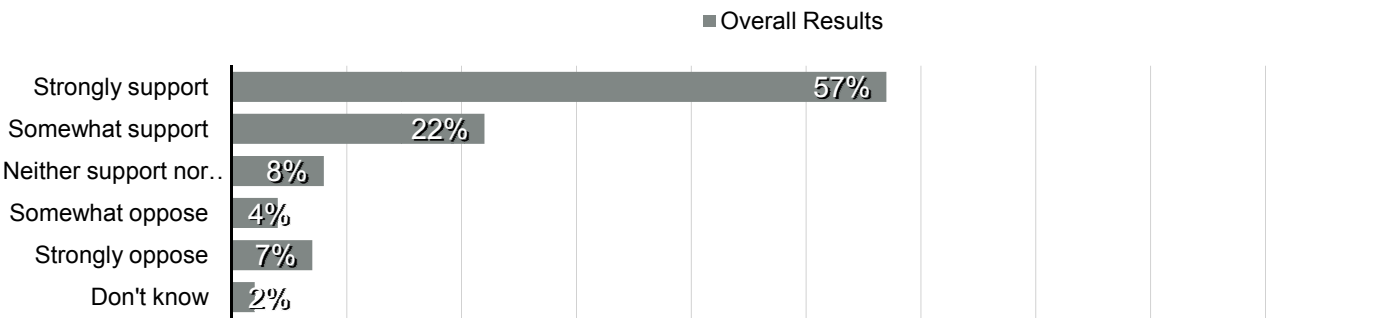
Approach #3: Prevention/Education Approach

This approach focuses on public education and awareness of issues and risks associated with prostitution. Examples could include developing a public education campaign to raise awareness about how individuals get involved in prostitution activities.



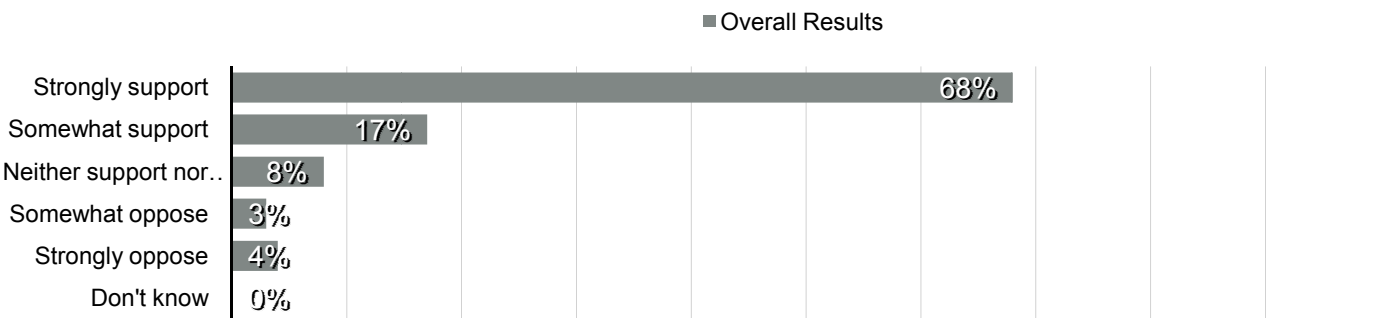
Approach #4: Community Development Approach

The approach looks at ways of working with individuals and/or groups to make positive changes in their communities. Examples could include setting up meetings between residents and others involved in prostitution to work on creating a safe environment for all.



Approach #5: Intervention Approach

This approach aims to help community members, including those working in prostitution, to remain safe and healthy and respectful of others' rights and needs. Examples could include contraceptive support and establishment of a community safety network.

METHODOLOGY

The following is an overview of the process for analyzing the open-ended data:

- Raw verbatims were sourced from the online survey responses generated by respondents.
- These were sent to our coding department and a senior Head Coder was assigned to the project. In fact, three of Ipsos' most experienced coding staff served as Supervisors and oversaw the coding for this project.
- Ipsos utilizes Ascribe™ for all our coding. Ascribe™ is provided by LanguageLogic and is a secure web-based program. Ascribe™ has much functionality to help aid us in coding. We are able to code multiple responses at once, search for similar responses, group ideas and provide multiple outputs for Data Processing in just a few clicks of a mouse. While the human eye must read and categorize each response, Ascribe™ helps facilitate the actual application of codes.
- A senior team of Ipsos' in-house coders were assembled for this project. All staff working on the study were briefed ahead of time, and given background on the study so that they were more informed on how respondents may have reacted and we better understood the responses.
- A standard add rule for creation of new codes of 1% of question total was used.
- Each verbatim response was reviewed in detail and all the relevant details/ sensible comments we assigned a code.
- Verbatim responses were reviewed by the Head Coder and the assigned coding team. Ideas and concepts were created based on what we were seeing in the responses. Common threads were grouped together.
- A draft code manual was reviewed by the Senior Ipsos project managers as well as other members of the Public Affairs team to ensure the codes were accurate and relevant – revisions to the draft manual were made as required. The same coding manual was applied across all data sources in this work.
- Once coding was completed, coders conducted a 100% self edit of their work, with a peer edit of at least 50%. Supervisors then edited all work at more than 50% of all completed work.
- Final coded verbatims and the final code manual were reviewed and approved by the project manager and other members of the Ipsos. Using Ascribe™, the Head Coder created a standard output for our studies in Quantum (a data tabulation program) and sent coding to Data Processing.
- A senior data analyst then created data tables for each question/Option.
