Subject: Designation of the Hattel Residence as a Municipal Historic Resource

The Calgary Heritage Authority (CHA), in accordance with its role to advise Council and Administration on heritage matters in the City of Calgary, would like to take this opportunity to support the designation of the William H. Hattel Residence, located in Elbow Park, as a Municipal Historic Resource.

The William H. Hattel Residence, built in 1920, is a one-storey bungalow-style house, clad in white stucco, with front-facing gable roof with lower front-facing and side cross-gables, and a deep wraparound front porch with lower side-gable roof. It is located on a tree-lined street of substantial single-family houses in the residential neighbourhood of Elbow Park.

The Hattel Residence is listed on the CHA *Inventory of Evaluated Historic Resources* as a Community Historic Resource.

Subject: Designation of the Treend Residence as a Municipal Historic Resource

The Calgary Heritage Authority (CHA), in accordance with its role to advise Council and Administration on heritage matters in the City of Calgary, would like to take this opportunity to support the designation of the Treend Residence, located in Cliff Bungalow, as a Municipal Historic Resource.

The Treend Residence is a solid-brick, one-storey house clad in red-brown brick. The low, expansive 1922 Prairie-style home has a medium-pitched, front-gabled roof with tall, corbelled brick chimneys, very deeply overhanging eaves and half-timbering and decorative wooden brackets in the main gable. The residence features a wide, wrap-around verandah with stairs to entrances on the east and south entrances. The front entry features an original oak door and sidelights, and a wide stairway with sandstone balustrade and large brick piers. The house is located on a large corner lot on a busy residential street, with many early 20th century homes on the west side. It is situated one block west of 4 ST SW, a traffic corridor and historic streetcar commercial street, in the early southwest inner city community of Cliff Bungalow.

The Treend Residence is listed on the CHA *Inventory of Evaluated Historic Resources* as a City Wide Historic Resource.
