Calgary A Background and Purpose

Background

Council Policy (*CFO013 Reserves*) and Administrative Policy (*FA-050 Financial Reserves*) approved in 2010

- · Every reserve is to be reviewed at least once every three years
- Review is conducted by an Administrative Reserve Review Committee

Purpose

Periodic review of each active reserve to ensure:

- Reserve activity meets all authorizing documents requirements;
- Reserve activity is in accordance with City reserve policies and procedures;
- · The reserve's purpose, conditions and/or restrictions are still relevant; and
- The reserve is still required in its current form.

2019 Triennial Reserve Review

Calgary A Review Recommendations (Substantive Changes)

- Artificial Turf Field Lifecycle Reserve include a one time contribution as an authorized use of this reserve and remove the restriction for Council approval of withdrawals from this reserve
- Legacy Parks Reserve and the Revolving Fund Reserve for General Land Purchase remove the special reporting requirements
- Calgary Building Services ("CBS") and Calgary Community Standards ("CCS") Sustainment Reserve - separate into 2 reserves: Planning & Development Sustainment Reserve and Business Licence Sustainment Reserve
- Planning & Development Sustainment Reserve and the Utility Sustainment reserve revise the reserve target balance formulas
- Corporate Housing Reserve revise to allow use for the Housing Incentive Program
- Fleet Services Reserve revise to allow for use in stabilizing the operating budget in the event of net asset disposal losses
