Introduction

In addition to funding through general taxation, some services make a direct charge for service. This is called a User Fee. All proposed user fees are set in accordance with the *User Fees and Subsidies Policy* (CFO010), which consider the full costs for providing the good or service, market demand and the extent of public benefit derived from the good or service.

Council approval of target long term tax support rates (i.e. the proportion of the service's full costs that are expected to be recovered through tax funding vs user fees) were approved by Council in report C2018-0586 on 2018 May 16. The tax support rate approval for the Appeals and Tribunals service is included in Attachment 7C, the deferral of setting a tax support rate for this service was also approved by Council as part of C2018-0586. Council then passed the actual rates and fees as part of the approvals associated with the One Calgary Service Plans and Budgets.

The annual adjustments process allows for changes and updates to fees and rates as necessary. This attachment contains the necessary approvals for all services that are seeking to change their user fees and rates outside of changes to business licensing fees which occurred earlier this year as part of report CPS2019-1309 along with a package of other changes related to streamlining processes and saving time and money for the business community.

Additionally, as part of the ongoing efforts of the organization to reduce costs to citizens, ALT directed self-supported services through ALT2019-0925, to either freeze or reduce rates and fees where possible during the 2020 Adjustments process. User fees that related to the changing environment and/or through a comprehensive review may also be proposed at this time. The summary table below provides an explanation of the adjustments, along with the average annual growth of fees 2020-2022. Detailed fee schedules for each service begin on page 7.

Waste & Recycling

Fee changes are a result of Waste & Recycling holding the 2019 Blue Cart Program Rate and Green Cart Program Rate for 2020. Customers will avoid an increase of \$0.30/household per month or \$3.60/yr to support Calgarians through the economic recovery. The Black Cart Program Rate remains at the 2019 level as described in report UCS2019-0364 Financial Model: Pay-as-You-Throw for the Residential Black Cart Program.



The Appeals & Tribunals service provides a means for the public to exercise legal rights to challenge certain decisions that impact them, largely mandated by the Municipal Government Act. The service provides a benefit to individuals who exercise those rights, and a broad benefit to society in allowing the availability of a process for challenging some decisions of local government in a manner that is less formal, lower-cost and more efficient than seeking recourse through the courts. Fees established for the Appeals & Tribunals service must be established within legislated constraints and should balance the affordability for those using the service with affordability for the public in maintaining a discrete system of justice that many members of the public may not avail themselves of.

Service Implications

Description of the service implications of the Long-Term Tax Support Rate.

The proposed fees for appeals and tribunals represent increases to existing rates in order to address evolving cost pressures in delivering service; however, the affordability of appeals in Calgary would continue to be the same as, or better than, that experienced by those appealing similar matters in other comparable jurisdictions. The proposed fees appropriately balance the individual benefit that service users receive with the societal benefits served by an appeals and tribunal system that is broadly accessible to the public.

Fee Implications

Preliminary projection of how the long-term tax support rate will affect fees. Actual fees will be presented to Council in the fall and approved in November.

BYLAW NUMBER 40M2019

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND BYLAW 40M2006, THE WATER UTILITY BYLAW

WHEREAS Council considers it necessary to change the fees set out in Bylaw 40M2006, The Water Utility Bylaw for 2020;

NOW THEREFORE THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. Bylaw 40M2006, The Water Utility Bylaw, as amended, is hereby further amended.
- 2. Schedule "A" is deleted and replaced with the following:

"SCHEDULE "A" - WATER RATES

The rates or charges described in this Schedule are shown for the years 2019, 2020, 2021 and 2022, and shall apply in the calendar year indicated (from January 1 to December 31, inclusive).

Monthly rates or charges described in this Schedule are based on a thirty (30) day period. The amount billed shall be established by dividing the applicable monthly rate or charge by thirty (30) to derive a daily rate and multiplying the daily rate by the actual number of days in the billing period.
