SPEAKING OF THE PRIVATE SECTOR, AND THE TOPIC OF PRIVATIZING A PORTION OF THE BLACK BINS,

CAN I PLEASE REMIND THE PEOPLE THAT PRIVATE SECTOR COMPANIES ARE IN THE BUSINESS OF MAKING MONEY? I FEAR THAT WE WILL SEE PRICE HIKES FOR THIS BASIC NEED THAT HAS BEEN SUCCESSFULLY PROVIDED BY THE CITY FOR NO PROFIT, AND THAT THE QUALITY OF THIS SERVICE WILL DECREASE IN THE FUTURE.

IF WE ARE SEEKING TO SAVE MONEY IN THE CITY, SHOULD WE THINK OF THINGS LIKE CANCELLING EXPENSE ACCOUNTS OF CITY OFFICIALS?

CAN WE COMBINE OR MERGE WARDS TO HAVE LESS COUNCILLORS? I KNOW, IT DOESN'T SOUND NICE TO HEAR OR THINK THAT YOU COULD NOT HAVE A JOB.

A REMINDER THAT IF 230 OR EVEN MORE JOBS GET CUT, THAT THIS WILL PUT AN EVEN GREATER STRAIN ON SOCIAL SERVICES LIKE UNEMPLOYMENT INSURANCE AND MENTAL HEALTH SUPPORT.

I CANNOT IMAGINE HOW IT MUST FEEL TO COME IN TO WORK EACH DAY FOR THE PAST FEW MONTHS KNOWING THAT YOUR COUNCIL IS CONSIDERING CUTTING YOUR JOB AND THAT THERE ARE FELLOW CITIZENS OUT THERE WISHING FOR YOU TO BE FIRED.
