Access to water is not guaranteed in the spring due to flood control measures which include lowering the water level of the Reservoir. The permit is not transferable from the registered permit holder to another individual. In-person payments can be made by the boat owner or by an individual authorized by the boat owner. In the latter case, a signed Letter of Authorization must accompany the individual. NO EXCEPTIONS WILL BE MADE. If you vacate your stall prior to October 31, a refund will be issued, but renewal rights for that stall will not be available. Please note that boats are parked at the owner's sole risk and the City of Calgary is not liable for any loss or damage to boats parked in rental spaces. The City of Calgary reserves the right to remove any boat at the owner's expense if the boat is parked in the wrong place, does not exhibit a sticker or is present after October 31st of the year.
