

What actions are Administration taking (both terms of enforcement and education) to response to the significant increase in panhandling activity in our city, particularly from motor vehicles, contravening Section 5 of the Panhandling Bylaw, 3M99? Can we do more education on what is and is not legal?
  - 2. Is Administration aware of any accidents or injuries related to panhandling from vehicles on Calgary roads?
