














<b>Petition summary and background</b>	Land use re-designation – 2240 26A street SW - LOC2017-0187 from RC2 to RC6.
<b>Action petitioned for</b>	We, the undersigned, are concerned citizens who oppose the proposed land use re-designation. We are concerned about the Density (Height & Mass) of the proposed 4 or 5 plex. This site is surrounded by bungalows on all sides. Most of the community has not has not been built to take advantage of the existing RC-1 zoning so up-zoning this one site beyond that creates a single site that is out of context. With the exception of the Main Streets Initiative the Killarney/Glengarry Area Re-development Plan has not been updated in around 30 years to address the best locations for increased density which is creating a free for all environments. We would like an opportunity as a community to re-work the re-development plan instead of spot zoning.
