

Regarding the proposed street names in SN2017-0005 ("Creekside", "Creekstone", "Creekrise", "Creekridge", "Creekview" and "Creekhaven") - all proposed street names share the first syllable with the existing road in Calgary – "Creek Road" located in NE Calgary. It is our opinion as a Policy Steward, that associated risks of confusion are reduced by the use of compound names as suggested by the applicant. Additionally, our initial assessment indicates that existing Creek Road is not a residential street, is located in a rarely used area and is accessible only through private streets. Lack of connection between originally proposed theme (coniferous trees theme) and proposed street names is less concerning as proposed theme may be expanded to a broader category to include newly proposed street names (e.g., wilderness theme, etc.) Therefore, we support recommendation for the approval of the proposed street names included in SN2017-0005.
