Re: Banning Conversion Therapy CPS2020-0532 – Stakeholder Engagement

I want to take this opportunity to provide an update to the questions posed during the 2020 May 13 SPC on Community and Protective Services meeting regarding stakeholder engagement for Banning Conversion Therapy CPS2020-0532.

The focus of the targeted stakeholder engagement was for feedback on clarity of the definitions of business, conversion therapy, and on the fines and violation sections of the proposed bylaw. A survey on these definitions was sent to 58 organizations that were selected based on the potential impact of the bylaw to their overall organization and consisted of both faith-based and LGBTQ2S+ organizations.

How did Administration research who to engage?

As the scope of the engagement was specified to target stakeholder groups, Administration conducted an online search of all faith governing entities, LGBTQ2S+, and student organizations and researchers. Administration also connected with the Psychological Association and Alberta Health Services. Internal partners, including the Indigenous Relations Office and neighbourhood support services, were consulted to check if the research of impacted stakeholders and contact information was verified as correct.

Administration also engaged those that expressed interest through City Councillors' offices, and organizations that heard through word of mouth. Administration took feedback from the survey and submissions through the Councillor's offices into consideration for improvements to clarity of the proposed bylaw, in designing potential public education, and in what training Community Peace Officers would entail.

How were the groups engaged? Did we use different languages?

An online survey to ensure clarity of the definitions of business, conversion therapy, and fines and violation was provided to 58 organizations. multilanguage options were not provided. The following organizations were engaged:

- 44 faith-based groups including organizations representing the Christian, Islamic, Sikh, Hindu and Buddhist faiths
- 8 LGBTQ2S+ organizations
- 6 were organizations such as a mental health organization or an aboriginal student centre

Was engagement provided to media channel, multi-ethnic media specifically?

Broad-based public marketing and/or communications was not utilized, as this was a targeted stakeholder approach. Broad-based public communications can proceed with Council's approval of the proposed bylaw. The goals of the communications strategy proceeding Council's approval are:

- Inform contributing stakeholders if or when the proposed bylaw is being introduced in addition to why and how it will be enforced.
- Communicate to citizens, including groups currently engaged in the business of conversion therapy, information on the new bylaw that prohibits conversion therapy and the penalties that can be imposed.

Were The City's engagement standards met?

The engagement followed The City's standard practice. Consideration was given to both the multi-cultural strategy and the engage inclusive engagement guide. The multi-cultural strategy talks about lack of awareness being the main barrier to participation. Administration chose to focus on maximizing the ability to inform the targeted stakeholders about the survey and provide them with the most time to respond. To best mitigate this, Administration deemed that email correspondence, including multiple follow-up opportunities with those who did not respond with immediacy, was the best way to provide the most notice to the targeted stakeholders. Administration focused on plain language and the clarity of the scope of the engagement.
