Dear Mr Carra,

I am a business owner in Ward 9. I have just been informed that the City is planning to permanently close 15th Street (between 42 Ave and 46 Ave) in Bonnybrook. I am very disappointed in the fact that this application was being made with no discussion having been had with the businesses in this area.

Our company has been at this location for over 30 years. We rely greatly on the access that this particular stretch of road provides to our community. There are only two routes out of this area that can be effectively used to go West. The only other one of these routes is the intersection of Ogden Road and Highfield Blvd/42 Avenue. That intersection is chaotic at the best of times. Not only does it have a turning lane that only allows a few vehicles through per light, but it is also a real hazard during the Winter months, as it leads directly up a very steep hill.

We, as a community, have already been put into much inconvenience during the temporary closure of 15th Street. Which, I might add, occurred at the same time as there were many lane closures happening on Highfield Blvd and into 42 Avenue (alongside the Century Casino). These lane closures are still in place as of this date.

For the City to decide to to close the only other option is, quite frankly, ridiculous. I would hope that, before any decision is made, there be an actual inspection of traffic usage in this area. At a time when our property & business taxes are being raised to astronomical proportions, it seems to me that the City might reconsider taking away an asset to our community (or lower our property taxes as we will soon be an undesirable area due to accessibility).

Hello Gian-Carlo Carra and Ward 9 team,

I am writing you on behalf of the ownership and staff of Dura Stainless and Sheet metal, newly located at 4227 Ogden Rd SE (the corner of 42nd Ave SE and Ogden rd) this April. We are a business employing 35 skilled workers in the field of sheet metal manufacturing.

We are opposed to the closure of 15St SE between 42nd Ave and 46th Ave SE. This road allows our staff faster access and alternative access to head west or south west.

If this road is closed permanently our staff would need to travel north on Ogden road then turning west on Highfield Blvd and south again on 12th street to 42nd avenue to get to the same location the 15st SE connector leads to. There is three more stop lights on this longer route, all left turns. If any of these busy roads are partially closed or totally closed due to accidents or construction there would be no good alternative to head west or south west from our location. As mentioned Ogden, Highfield Blvd and 12th/11th street are extremely busy during rush hours, particularly 12th/11th Street since the bicycle lanes have been added and losing the 15th st SE connector will make it even worse. There is no further access to the south due to the Bow River until Glenmore Trail and the Graves Bridge.

The concern is not just staff heading home or to work as we have our service fleet of 10 vehicles that travel to and from our location thought each business day, and valuable time and fuel will be often wasted to travel the longer slower route.

Thank you for taking the time to hear our concerns.

15 Street also alleviates traffic congestion to Ogden Road which has been very difficult to navigate over the last year. There were times were we were quite literally unable to get out of our area because of routes being blocked by what appeared to be poor coordination between various work crews. This would not have been an issue if 15 street had been open.

The road closure signs used to indicate that it would be reopened end of December 2016. They now have the proposed reopen date blanked out. There is absolutely nothing indicating that the situation has changed from a temporary closure to a possible permanent closure on those signs This implies to me that the decision has already been made.

I am very much against this closure and would like and appreciate it if the road remains open.

This letter may be futile as I have not seen nor had any communication from you nor any representative of the City of Calgary regarding this matter. Kind of like shifting the tax shortfall burden from the big Corporations downtown to the small businesses in surrounding areas.

Hello,

I am writing to register my disagreement to the permanent closure of 15 St SE. This little route through the industrial area is very important to moving traffic on a day-to-day basis. I work on 17th St and 42nd Ave. While 15 St has been closed 'temporarily', the access to points south and west has been inadequate. There is no line between 42 Ave SE and Blackfoot without first going north. It is also a very long distance south before you can turn west.

It also leaves a large area with only 3 access/egress When traffic problems occur anywhere between Glenmore Tr to the south and Blackfoot Tr to the north, using 46th Ave, 15th St and 42nd Ave moves a lot of traffic east-west to move around the problem.

I also feel like this 'temporary' closure was bit of a shell game. I certainly heard no invitation for community input to this. Not a good feeling when I both live and work in your ward.

Dear Mr. Carlo-Carra:

It has been brought to my attention that the originally planned construction of 15th St. S.E. between 42nd Ave and 46th Ave SE (along with the adjoining closure of Highfield Crescent SE that leads up to 46th Ave and 15th St SE) in the Bonnybrook Industrial Park was slated to be completed by the start of January 2017. Now it has been apparently decided within your ward for whatever reason or decision that you and your fellow members of city council, individually or collectively, have felt that the usage of 15th St. S.E. is no longer feasible, and is to be decided that the section of said roadway is to be shut down permanently.

I am an auto parts delivery driver that is currently employed by a local reputable business that has been using 15th St SE on a daily basis prior to the road closure. As a driver that has clients and customers in the Bonnybrook area that give my company continuous business, myself and many other of my fellow drivers/employees of the company feel that the permanent closure of 15th St S.E. will not only have a negative impact on traffic volume, but will also have negative ramifications on our business between efficient delivery times and the bottom line.

Since the temporary closure of 15th St SE, my delivery route for myself and my fellow drivers that serve our customers in the Bonnybrook Industrial Park has been altered to the point where by having to detour via 12th St SE and Highfield Blvd SE not only contributes negatively by adding additional driving and waiting time in an already high volume route during peak times, but also will cut deeply into the crucial delivery times of serving our customers, therefore effecting our business and our bottom line.

Having to get to Ogden Rd. SE alone adds an additional 5 minutes to our delivery route and to many other drivers that operate within the same field, this is the deciding factor which determines if we still retain our business with our customers or if we lose them.

15th St SE in Bonnybrook is a vital route and gateway that helps in the efficiency of my delivery routes to my customers that I serve in the area. It would be a hinderance of time efficiency for my business and for general motor commuters if you and city council carry the motion to permanently close the road and create more traffic congestion on an already overloaded route on 12th St SE and Highfield Blvd SE.

So I ask you, Mr. Carlo-Carra, to please reconsider the pros and cons and to reevaluate your decision on closing 15th St SE in Bonnybrook. As a tax paying citizen of the city of Calgary, I hold you and city council to task in making the correct and informed decision to help better make our city's infrastructure more efficient for business and for the general public.
