

- Authorized by the Municipal Government Act and a City Bylaw:
 - 7% penalty applied July 1 to unpaid current year tax balance.
 - 7% penalty applied October 1 to unpaid current year tax balance.
 - Any outstanding tax balance from a prior tax year (arrears) assessed a 1% penalty on the first of each month.
- Under section 347 Council is the only authority who can cancel part or the whole value of tax.





- Tax payment deadline has been extended from June 30 to September 30 without late payment penalties.
- 7% penalty applied on July 1 was cancelled. Property owners have until September 30 to pay their 2020 tax bill without penalty.
- Any unpaid 2020 tax balance as of October 1 is scheduled to have a late payment penalty applied.
- The Tax Instalment Payment Plan (TIPP) has suspended its 2% filing fee for taxpayers who join TIPP between January 1, 2020, and January 1, 2021.



Factors Influencing Recommendations

- City's short-term borrowing costs = 0.45% to 0.55%
- City's average return on investment = 2.47%
- Availability of retail credit products based on prime rate of 2.45%
- Mortgage requirement to pay property taxes to avoid default
- Payment deadlines and penalty amounts of other Alberta municipalities
- Balancing the interests of City and property owners





That Council:

- Approve the cancellation of 50% of the portion of the property tax comprised of the penalties imposed under section 2(b) of Bylaw Number 8M2002 to be charged on 2020 October 1, and;
- 2. Approve that the requirement for a taxpayer who joins the Tax Instalment Payment Plan (TIPP) after January 1 of the current year to pay the total of missed instalments beginning from January 1 of the current year, under Section 7(5) of Bylaw Number 9M2002, be waived up to and including 2020 December 31.
