OPTION 2 - Both in October with changes (except UFC)

Guidebook Recommendations

- c. Forward the proposed Bylaw, and report PUD2020-0721, to accommodate the required advertising, directly to the 2020 October 5 Combined Meeting of Council.
- 2. Recommend that Council hold a Public Hearing for the proposed bylaw at the 2020 October 5 Combined Meeting of Council:
 - a. Give three readings to the proposed Bylaw;
