


# BEING A BYLAW OF THE CITY OF CALGARY TO AMEND THE LAND USE BYLAW 1P2007 (LAND USE AMENDMENT LOC2016-0133)

### DC DIRECT CONTROL DISTRICT

### **Purpose**

- 1 This Direct Control District is intended to:
  - (a) add the **use** of **Liquor Store** to the existing **discretionary uses**; and
  - (b) transition the *parcel* to the Regional Shopping Centre (C-R3) District under Land Use Bylaw 1P2007.

### Compliance with Bylaw 1P2007

Unless otherwise specified, the rules and provisions of Parts 1, 2, 3 and 4 of Bylaw 1P2007 apply to this Direct Control District.

#### Reference to Bylaw 1P2007

Within this Direct Control District, a reference to a section of Bylaw 1P2007 is deemed to be a reference to the section as amended from time to time.

#### **Permited Uses**

There are no **permitted uses** in this Direct Control District.

# Bylaw 1P2007 District Rules

Unless otherwise specified the rules of the Commercial - Regional 3 (C-R3) District of Bylaw 1P2007 apply in this Direct Control District.

# **Parking**

Aminimum of 1250 motor vehicle parking stalls must be maintained in the Direct Control District at all times.
