RE: Ricardo Ranch Business Case - Alexander Soutzo

Your Worship and Members of Council,

I am writing on behalf of my client Alexander Soutzo who is landowner in the Ricardo Ranch business case area. We are requesting that Council approve the Ricardo Ranch business case.

We are currently in a situation where the City is constructing both the Ogden Water Feeder Main and the Seton Storm Trunk and outfall on Mr. Soutzo's land. Much was said at Priorities and Finance committee about the City front ending infrastructure and requiring payback in a timely manner for same. If the infrastructure is in our land, and we cannot develop due to a growth management overlay (CMO), we are not in any position to begin to repay the City and its taxpayers for their investment. We wish to undertake site development and repay the City. To date we are in a pre-application process and subsequent to the completion of that process we will be submitting a Phase 1 land use and outline plan proposal.

We simply should not be here. Ricardo Ranch was provided with an Asterisk (*) in 2018 as a recommended business case, as part of Rangeview, but we didn't have an Area Structure Plan in place. Once that plan was in place, we felt the GMO could be removed because of the strength of our business case. However, the ASP included a GMO, and at the ASP public hearing we requested it be removed, it was not, and we were deferred to the 2020 busines case process. Councilor Keating provided the following in the minutes of 18 November 2019:

"Ricardo Ranch supports the continuation of build out to both Seton and Rangeview Plan Areas, the City should consider the Plan area as part of a larger Southeast community when evaluating proposals to remove a portion of the Overlay provided it can be demonstrated to the satisfaction of Council, that the proposal leverages existing capital infrastructure investment already made in Seton and Rangeview." This business case has no operational or capital expenditures, an overpass, water, sewer and storm are in place and we are ready and willing to proceed and repay the City, and its taxpayers, back for their investment If this business case does not proceed these assets are fundamentally stranded and the City will continue to carry the debt.
