Action Plan Mid-Cycle Adjustments (C2016-0863)

"3. Authorize the Deputy City Manager to continue to identify capital funding sources, including allocations and efficiencies from existing capital budgets and transfer funds to the Budget Savings Account to support recommendation 4.

"4. Direct the Deputy City Manager to return to Council no later than Q2 2017 with recommendations for new, or currently unfunded investment projects;"

The strategy is comprised of the following components:


- 1, Critically examine and recast cash flows

- Identify and approve associated operating budget funding



Corporate Capacity Identified (by Funding Source)

A comprehensive review was conducted which identified capacity in the following funding sources for potential reinvestment.

Project Assessment and Selection (Corporate Capacity Project Investment Filters)

1. Strategic Alignment

- Advances & aligns with strategic direction (i.e. Council Priorities, Capital Investment Plan)
- Required to meet regulatory requirement
- Considered projects that:
 - Provide short term economic stimulus
 - Add resilience in the community
 - Maintain and preserve existing infrastructure investments
 - Build a great community through legacy investments
 - Leverage public and private investment

2. Project Readiness*

- Design, permits, approvals, leading infrastructure, asset, land ownership in place
- City has resource capacity or alternative delivery option
- Alignment with stakeholders (if needed)
 - * Not all projects required to be shovel ready as some are longer term city shaping projects

3. Project Financials

- Project cash flow, internal and external funding sources identified
- Impact on operating identified (cost avoidance, cost reduction, increased operating)

4. Project Value and Benefit

Economic, Social and Environmental Indicators as available/ applicable

5. Funding Alignment

Federal & provincial grants, private contributions, off-site levies, reserve funds
