

Rapid Housing Initiative (RHI)

- \$1 billion in capital grants
- <u>Target:</u> Vulnerable people in severe housing need
- Long-term, permanent affordable housing through:
 - Modular multi-unit construction
 - Acquisition & conversion of non-residential (i.e. hotel, office)
 - > Reclamation of closed buildings in need of rehabilitation


