**This petition is signed by business owners in the Kensington Business Revitalization Zone, residents in the Sunnyside and Hillhurst communities, and surrounding areas. We respectfully request Honourable Mayor Naheed Nenshi, Councillor Druh Farrell, and City Council oppose these applications for rezoning.**

The intent of the Area Redevelopment Plan ("ARP") for the Kensington BRZ and the City of Calgary Action Plan 2015-2018 was to create a vibrant area or a 'city of inspiring neighbourhoods'. The current zoning is in place to support the existing shopping district by attracting small store front retail stops, thereby attracting new customers to the area. Attracting new small retail businesses would support the continued success of the small business owners that have made up this business district in some instances, for more than two decades.

If the zoning change is successful it would permit large businesses such as banks, liquor stores, medical and personal services at street level. This will create an opportunity for big box businesses to overshadow our current small businesses and limit this neighbourhood in its ability to be unique and inspired. Should this zoning change application be approved for one developer, it will open the door for any and all developments.

For years we have participated in numerous discussions, years of planning, financing and volunteering, all to develop and support the current and recent ARP. All developers were well aware of the zoning requirements when they chose to build in Kensington. If the application to rezone is accepted, it would mean City Council would be completely ignoring the years of work that we participated in, especially in light of the fact that the new ARP is still in its infancy.

It is concerning that the city planning commission has recommended these changes when they appear to solely benefit the developer and not the business district or the desires of the community.

None of the above applications will attract new retail customers or create a fun and vibrant shopping district, which has been the focus of the current zoning of the ARP. All of the new applications saturate a small customer base with similar businesses, seriously putting at risk the small business owners currently operating in the Kensington business district. The ARP development was meant to create small business opportunities not to attract "big box" businesses.

We respectfully request city council stand by its ARP recommendations for the Kensington BRZ shopping district and continue to support new and current small businesses and create a unique vibrant shopping district for years to come.
