We respectfully request Honourable Mayor Naheed Nenshi, Councillor Druh Farrell, and City Council oppose these applications for rezoning.

The intent of the Area Redevelopment Plan ("ARP") for the Kensington BRZ and the City of Calgary Action Plan 2015-2018 was to create a vibrant area or a 'city of inspiring neighbourhoods'. The current zoning is in place to support the existing shopping district by attracting small store front retail stops, thereby attracting new customers to the area. Attracting new small retail businesses would support the continued success of the small business owners that have made up this business district in some instances, for more than two decades.

All of the new applications saturate a small customer base with similar businesses, seriously putting at risk the small business owners currently operating in the Kensington business district.
