Strategy Overview

The first step of the strategy was to enlist the support of an Outreach Consultant who could help the CDC articulate a well thought out strategic plan. Manna Consulting was hired.

The Strategy developed was to first discuss with the affected Ward 9 and Ward 11 Councillors and make them aware of our proposal to buy and repurpose the Holiday Inn Calgary Hotel at 4206 Macleod Trail South to Affordable Housing and gather any concerns or comments they may have. Our next step in the strategy was to contact the Community Associations' Boards and review the proposal with them and get their feedback. We then planned on holding virtual Q&A Sessions with the Community residents to hear their comments and concerns. We would then incorporate what was heard into action items for the CDC Team to consider.

In addition to the above, the CDC proposal was to be documented and distributed to all businesses along Macleod Trail between 50th Ave and 34th Ave. to make them aware of the proposal and solicit feedback.

Tactics

- A Zoom meeting was held with Ward 9 Councillor Carra on December 18th, 2020 to share the proposal, He was very supportive and wants to see this go ahead, as the Hotel is in his Ward.
- 2. A Zoom meeting was held with Ward 11 Councillor Farkas on December 16th, 2020 to share the proposal. While supportive, he did caution there might be some push back from the Community.
- 3. A Zoom Call was held with the Parkhill Stanley Park Community Association Board on January 8th to discuss the proposal. They also were supportive but indicated there were some in the community who would push back. The Community Association sent out 355 emails to residents advising of the CDC proposal and two upcoming Virtual Zoom Q&A sessions that they could participate in on January 21st.
- 4. A Zoom Call was held with the Elboya Heights Brittania Community Association on January 19th to discuss the proposal. The Board was fully in favour of the CDC proposal. They will also be sending emails to their residents to advise of an upcoming Virtual Zoom Q&A session on February 10th.
- 5. On January 21st there were two Virtual Zoom Q&A sessions with the residents of Parkhill and Stanley Park. The first Meeting was from 1:00PM 3:00PM and there were 12

- attendees during the 2 hours. The second meeting was from 7:00pm 9:00pm and there were 14 attendees during the 2 hours.
- 6. On February 10th there will be a Virtual Zoom Q&A session with the residents of Elboya Heights-Brittania from 7:00pm to 9:00pm.
- 7. A Flyer drop-off with the CDC proposal was hand delivered to 110 businesses on both sides of Macleod Trail on December 22nd, 2020. A contact name and number was on the flyer so business owners could call should they have questions. There has been no response from the business community to-date.

The main issues raised and ideas were:

- 1. Clarifying the proposal, the demographics of potential residents, the intake process used, how will safety be maintained, will the site become an eyesore.
- 2. Concern over the number of Care facilities in the area already, While it was explained this is Affordable Housing, they felt it still might draw undesirable homeless people into the area who could cause trouble.
- 3. What complaints or concerns have we had from neighbours at other other properties?
- 4. Are we considering what the future redevelopment and vision for Macleod Trail is?
- 5. Will the repurposed hotel affect the residential properties in Parkhill Staley Park?
- 6. Will the pedestrian access from the 39th Ave LRT to 42nd Ave through the hotel property be maintained?

The issues raised and ideas:

- 1. Try to ensure a diverse mix, not just all male.
- 2. Ensure a Good Neighbour Agreement is developed to help work with the community on initiatives to improve the area.
- 3. The CDC will be maintaining the 39th Ave LRT Pedestrian Access through the property.
- 4. As the CDC is a sobriety-based organization, we were asked to consider adding a sober night club with activities such as pool, darts, ping pong, etc. that those in the community could also use.
- 5. Several items raised could enhance our operations security personnel training
