Background & Methodology

Background

The City of Calgary surveys citizens about their opinions, preferences and attitudes in order to help support data-driven City decision-making. The Citizen Perspectives Survey is one of the ways by which data are collected and is conducted multiple times throughout the year. Recently, The City has used the Citizen Perspectives Survey to better understand Calgarian's opinions, beliefs and concerns about the COVID-19 pandemic. This report presents the results of The City's third COVID-19 Snapshot survey.

Methodology

The survey was conducted by Leger from June 8 to 14, 2020 with 500 Calgarians (aged 18 years or older) via phone using random digit dialing (RDD). The survey was conducted using numbers from both landlines (34%) and cell phones (66%) to obtain a random and statistically representative sample of Calgarians. The survey averaged 16.5 minutes in duration. The margin of error (MOE) for the total sample of n=500 is \pm 4.4 percentage points. 19 times out of 20.

To ensure the data was gathered from a representative group of Calgarians, sample quotas were set by age, gender, and city quadrant of the general population aged 18 and older. Data were then weighted to the 2016 Civic Census for age and gender.

Where applicable, results from the first two Snapshots are shown for comparison purposes. Where a difference between Snapshots is statistically significant, it is noted with an arrow: ψ or \uparrow

Statistically significant differences across demograhics such as age groups and gender are noted in the Key Findings.



Key Findings

Awareness of The City's current efforts to limit the spread of COVID-19 is still strong and the large majority of Calgarians agree that as The City reopens its services, it's taking precautions to limit the spread of the virus.

- The large majority (90%) of Calgarians continue to be aware of The City's current efforts to limit the spread of COVID-19, although it appears to be trending down slightly since late April/early May. Similarly, the majority (89%) agree ("strongly" or "somewhat") that as The City reopens its services, it's taking precautions to limit the spread of the virus, with nearly one-half (46%) "strongly" agreeing with this statement.
 - More females than males agree they're aware of The City's current efforts to limit the spread of COVID-19 (96% vs. 84%, respectively) and that as The City reopens its services, it's taking precautions to limit the spread of COVID-19 (93% vs. 84%).

The majority of Calgarians continue to think they have enough information about The City's COVID-19 response, support available from The City to individuals and, to a lesser extent, about support available to businesses.

- On par with the first two Snapshots, the majority of Calgarians agree ("strongly" or "somewhat") they have enough
 information about what The City is doing to respond to COVID-19 (88%) and about support available from The City to
 individuals (78%). When it comes to having enough information about support available from The City to businesses,
 fewer now agree with this (70% vs. 78% in Snapshot 1).
 - Nearly twice as many males as females (15% vs. 8%) disagree that they have enough information about what The City is doing to respond to COVID-19.
 - Those aged 18 to 34 years are more likely than those 35 years of age or older to agree they have enough
 information about support available from The City to businesses (80% of 18 34 vs. 68% of 35 64 and 61%
 of 65+).



Key Findings

Consistent with the first two Snapshots, the large majority of Calgarians are satisfied with The City's COVID-19 response, agreeing that it's been helpful and quick enough, while fewer (although still a majority) trust The City when it comes to its pandemic response.

- Nearly all Calgarians (97%) agree ("strongly" or "somewhat") they understand what to do to limit the spread of COVID-19.
- The large majority agree ("strongly" or "somewhat") The City's response has been helpful (87%) and quick enough (85%) and that the information provided by The City has been clear (87%).
 - More females than males agree that The City's response has been helpful (91% vs. 83%) and quick enough (90% vs. 81%).
- Consistent with the last two Snapshots, the large majority (86%) of Calgarians are satisfied ("very" or "somewhat") with The City's COVID-19 response, with one-third (33%) "very" satisfied.
 - Slightly more females than males (89% vs. 83%) are satisfied with The City's COVID-19 response.
- The majority (66%) of Calgarians continue to trust ("a great deal" or "a little") The City in terms of its COVID-19 response, with two-in-five (39%) reporting they trust The City "a great deal."
 - More males than females (15% vs. 7%) distrust ("a great deal" or "a little") The City regarding the COVID-19 response while more females than males (26% vs. 18%) are neutral.
 - More seniors (those aged 65 years or older) than Calgarians between the ages of 18 and 64 distrust The City (21% of 65+ vs. 10% of 18 34 and 9% of 35 64).



Key Findings

The large majority of Calgarians are in agreement that the pandemic poses a major threat to Calgary's economy but are split on the threat level regarding their personal financial situation and day-to-day life in their community.

- Although the majority of Calgarians continue to perceive the pandemic to be a major threat to Calgary's economy, this
 measure is trending down and has dropped to 87% from 92% in the first Snapshot.
 - More females than males (90% vs. 83%) perceive the pandemic to be a major threat to Calgary's economy.
- Compared to the first two Snapshots, fewer Calgarians say the pandemic is a major threat to their personal financial situation (24%, down from 30% in Snapshot 2) while the proportion perceiving it as no threat is trending up (24%, up from 17% in Snapshot 1) and one-half (51%) think it's a minor threat.
 - More males than females (29% vs. 19%) see it as a major threat to their personal financial situation.
 - More seniors (aged 65 years or older) than younger Calgarians (aged 18 to 64 years) say the pandemic poses
 no threat to their personal financial situation.
- There's a downward trend in seeing the pandemic as a major threat to day-to-day life in one's community (37%, down from 46% in Snapshot 1), while one-half (51%) say it's a minor threat and the proportion of Calgarians who think it's no threat has risen to 12% from 7% in the first two Snapshots.
 - Males are more likely than females (17% vs. 7%) to think the pandemic poses no threat to day-to-day life in their community.
 - Compared to their younger counterparts (aged 18 to 34 years), more Calgarians aged 35 years or older think the pandemic is no threat to day-to-day life in their community (14% 35 64 and 15% 65+ vs. 7% 18 24).



Key Findings

More Calgarians see the pandemic as a major threat to the health of Calgary's population as a whole than to their own mental or physical health, with the majority perceive the pandemic to be a minor or no threat to their mental and/or physical health.

- Compared to Snapshot 2, fewer see it as a major threat to the health of Calgary's population as a whole (47%, down from 58% in Snapshot 2) and Calgarians are now roughly split between seeing it as a major versus a minor threat, with only 7% saying it's no threat.
- The perceived threat of the pandemic to one's mental health is on par with Snapshot 2, with just over one-quarter (28%) thinking it's a major threat and one-half (49%) seeing it as a minor threat. Results are similar regarding one's physical health, with one-in-five (22%) thinking the pandemic is a major threat, 56% seeing it as a minor threat, and one-in-five (22%) saying it's no threat.
 - More females than males (33% vs. 23%) perceive the pandemic to be a major threat to their mental health.
 - More Calgarians aged 18 to 34 years than those 35 to 64 and 65 or older (41% vs. 24% and 18%, respectively) think the pandemic is a major threat to their mental health.
 - Calgarians aged 65 years or older are more likely than those younger than 65 to perceive the pandemic as a major threat to their physical health (33% 65+ vs. 20% 18 34 and 19% 35 64) and to say it's not a threat to their mental health (35% vs. 17% 18 -34 and 22% 35 64).



Key Findings

There remains concern about oneself, a household member and/or a family or friend outside of their household becoming ill from COVID-19 and a majority of Calgarians find it stressful to be out in public during the pandemic.

- Overall concern ("very" or "somewhat" concerned) with oneself or a household member becoming ill from COVID-19 (58% and 66%, respectively) hasn't changed since Snapshot 1; however, the proportions reporting being "very" concerned are trending down.
 - Those aged 18 to 24 years are more likely than other Calgarians to be concerned that someone in their household will become ill from COVID-19 (85% vs. 68% 25 34, 63% 35 64 and 57% 65+).
 - Respondents with children (under the age of 18 years) in the home are more likely than others to be concerned about someone in their household becoming ill from COVID-19 (75% vs. 61%).
 - Those with a senior (aged 65 years or older) in the household are more likely than others to be concerned about someone in their household becoming ill from COVID-19 (75% vs. 63%).
- Being "very" concerned with family/friends outside the household becoming ill from COVID-19 is also trending down
 and saw a statistically significant drop in overall concern from 85% in the first two Snapshots to 79%.
- The majority of Calgarians continue to find it stressful ("very" or "somewhat") to be out in public during the pandemic (62%, on par with 66% in Snapshot 2), although a minority find it "very" stressful (13%, consistent with 16% in Snapshot 2).
 - More females than males (70% vs. 53%) report they find it stressful to be out in public during the pandemic, with twice as many females as males (17% vs. 8%) saying it's "very" stressful.



Key Findings

Calgarians' physical health has mostly stayed about the same or improved since the lifting of restrictions put in place to deal with the pandemic.

- In Snapshot 2, three-in-ten Calgarians (29%) reported that their physical health had worsened since the pandemic began and restrictions were put in place while the majority (62%) said it stayed the same as before the pandemic. Since then, three-quarters (75%) report that in the two to three weeks following the lifting of restrictions put in place to deal with the pandemic, their physical health has stayed the same and more than one-in-ten (16%) say it's improved.
 - More males than females (21% vs. 11%) report that their physical health has improved since restrictions started being lifted while more females than males say it's stayed about the same (80% vs. 70%).
 - Calgarians aged 65 years or older are more likely than others to say that since the restrictions started being lifted on May 25, their physical health has stayed about the same (86% vs. 72% 18 24 and 74% 35 64). More Calgarians aged 18 to 34 and 35 to 54 years (16% and 20%, respectively) than those 65 or older (4%) say their physical health has improved.
 - Respondents who have children (under the age of 18 years) in the home are more likely than those who don't to say their physical health has improved since the lifting of restrictions (22% vs. 12%).



Key Findings

The lifting of restrictions put in place because of the pandemic had a positive impact on the mental health of one-quarter of Calgarians although some report that their mental health has worsened.

- In Snapshot 2, two-in-five Calgarians (43%) reported that their mental health had worsened since the pandemic began and restrictions were put in place. One-quarter of Calgarians (24%) report that in the two to three weeks following the lifting of restrictions put in place to deal with the pandemic, their mental health has improved; however, 15% say their mental health has worsened.
 - Calgarians aged 65 years or older are more likely than others to say that since the restrictions started being lifted on May 25, their mental health has stayed about the same (81% vs. 51% 18 – 24 and 61% 35 – 64).
 - More Calgarians aged 18 to 34 and 35 to 54 years (29% and 26%, respectively) than those 65 or older (5%) say their mental health has improved.
 - Respondents who have children (under the age of 18 years) in the home are more likely than those who don't to say their mental health has improved since the lifting of restrictions (33% vs. 18%).



Key Findings

The lifting of restrictions put in place because of the pandemic has not improved the personal financial situation of most Calgarians and after losing their job or pay either temporarily or permanently, a minority are working again.

- In Snapshot 2, slightly more than two-in-five Calgarians (44%) reported that their personal financial situation had worsened since the pandemic began and restrictions were put in place. In the two to three weeks following the lifting of restrictions, the majority (75%) say their personal financial situation has stayed the same while nearly one-in-five (17%) say it's worsened and only around one-in-ten (8%) report that it's improved.
 - Calgarians aged 18 to 34 and those 35 to 64 are more likely than those 65 or older to report that their personal financial situation has improved since the restrictions started being lifted (11% and 7% vs. 2%, respectively).
- Of Calgarians who were employed at the beginning of the pandemic and experienced job or income loss as a result of the pandemic, two-in-five (41%) report having lost some pay or some income from work (as opposed to losing their job completely). Just as many (40%) are not yet working again after losing their job or pay temporarily (23%) or permanently (17%) while more than one-in-ten (16%) lost their job or pay but are working again.
 - More young adults (those aged 18 to 24 years) than Calgarians between the ages of 25 and 64 years
 experienced a job loss or income loss due to the pandemic (77% 18 24 vs. 48% 25 34 and 38% 35 64).
 The difference between the proportion of 18 to 24 year olds and those aged 65 years or older (62%) is not
 statistically significant.
 - More males than females (53% vs. 27%) lost some of their work or some of their work income as a result of the pandemic.



Key Findings

Fewer Calgarians who have a mortgage or pay rent are now reporting a negative impact of the pandemic on their capacity to make these payments and fewer homeowners are reporting a negative impact on their capacity to pay property taxes.

- The negative financial impacts of the pandemic on Calgarians has remained relatively consistent across the three Snapshots, with two exceptions. The proportion experiencing an impact on their capacity to pay mortgage/rent declined from 27% (of those who pay mortgage or rent) in Snapshot 2 to 19% and the proportion reporting an impact on their capacity to pay property taxes is trending down and is now at 17%, down from 26% in Snapshot 1.
 - Among those with retirement savings and/or other investments, more males than females (62% vs. 51%) report that the pandemic had a negative impact on these savings/investments.
 - Among Calgarians who have an income, more 18 to 34 than others report a decrease in their income (61% vs. 47% 35 – 64 and 34% 65+).
- The majority (80%) of Calgarians with a mortgage are able to pay all of their regular mortage payment in June and
 just as many expect to be able to do so in July. These results are on par with those of the first two Snapshots;
 however, the proportion of mortgage holders who couldn't pay any of their payment in June was only 5%, down from
 11% in May.
- Compared to the first two Snapshots, more homeowners in Calgary expect to pay all of their property tax to The City this year (89%, up from 81%) while the proportion who expect to pay most or some dropped to 9% from 14% in Snapshot 2. One-in-twenty (5%) expect to pay most and 4% some of their property tax. Note that property tax bills were mailed on May 25, prior to data collection for Snapshot 3 but after data collection for Snapshot 2.
- The majority of renters (84%) are able to pay all of their rent payment in June and just as many (83%) expect to be able to do so in July.
 - More female renters than male renters (92% vs. 75%) expect to be able to pay their entire rent payment in July while more males than females (21% vs. 5%) expect to pay most or some.

Key Findings

Consistent use of a face mask when in public and confined spaces is reported by a minority of Calgarians although there is strong support for making them mandatory.

- One-third (34%) of Calgarians say they always wear a face mask in public and confined spaces such as grocery stores, shopping malls and on public transit and 20% usually wear one. One-quarter (26%) wear one only sometimes and around one-in-five (18%) say they never wear a face mask in public.
 - More females than males (41% vs. 28%) say they always wear a face mask in public and confined spaces while more males than females (23% vs. 14%) say they never wear a face mask.
 - More seniors (aged 65 years or older) than other Calgarians report always wearing a face mask in public and confined spaces (48% vs. 34% of 18 to 34 and 30% of 35 to 64).
 - Those with a senior (aged 65 years or older) in the household are more likely than others to report always wearing a mask in public and confined spaces (44% vs. 32%).
- Nearly one-half (45%) "strongly" support making face masks/coverings mandatory in public and confined spaces and another 29% "somewhat" support it. One-quarter (25%) of Calgarians either "somewhat" or "strongly" oppose making face masks/coverings mandatory for everyone.
 - More females than males (80% vs. 67%) support making face masks/coverings mandatory for all people when in public and confined spaces.
 - Respondents who have children (under the age of 18 years) in the home are more likely than those who don't
 to oppose mandatory use of face masks/coverings for all people in public and confined spaces (31% vs. 22%).
 - Those with a senior (aged 65 years or older) in the household are more likely than others to support mandatory
 use of face masks/coverings (85% vs. 71%).



Key Findings

The majority of Calgarians continue to want government decision-makers to balance public health and economic considerations when deciding how to re-open the economy and a small minority think the economy should be the priority.

- Calgarians' opinions about whether government decision-makers should prioritize public health or the economy when
 deciding how to re-open the economy hasn't changed since Snapshot 2. Two-thirds (66%) prefer that public health
 and the economy are equally considered, one-quarter (25%) think public health should be prioritized over the
 economy and the remaining one-in-ten (9%) opt for the economy to be the priority.
 - While the majority of both males and females (63% and 68%) think that government decision-makers should find a balance between public health and the economy when re-opening the economy, more males than females think the economy should be the priority (13% vs. 5%).

Key Findings

While Calgarians are now more likely to report being comfortable with some activities after restrictions are lifted,* it's mainly due to an increase in the proportion saying they'll be "somewhat" (as opposed to "very") comfortable.

- Compared to Snapshot 2, more Calgarians say they'll be comfortable doing certain activities as restrictions are lifted: receiving paramedical services (e.g. physiotherapy, chiropractic treatments, seeing a dentist), getting personal services (e.g. haircut, manicure, massage, cosmetic treatment), visiting public places such as malls or libraries, and eating in restaurants. These increases are mostly due to an increase in the proportion saying they'll be "somewhat" comfortable, as opposed to "very" comfortable.
 - Compared to Calgarians aged 35 years or older, more 18 to 34 year olds will be comfortable with receiving physiotherapy, chiropractic treatment and going to the dentist (86% vs. 77% 35 64 and 71% 65+).
 - Those with a senior (aged 65 years or older) in the household are less likely than others to say they'll feel comfortable receiving physiotherapy, chiropractic treatment and going to the dentist (70% vs. 81%).
- Comfort levels with going to their workplace/office, going to the gym or a fitness facility, using public transit, and attending a large public gathering have not changed since Snapshot 2.
 - More males than females say they'll be comfortable going to the gym/a fitness facility (51% vs. 41%) as well as using public transit (46% vs. 34%).
 - Twice as many males as females (33% vs. 16%) report they'll be comfortable attending a large public gathering.

Key Findings

The majority of Calgarians who normally use playfields or public parks, playgrounds, City golf courses and/or tennis or pickleball courts plan to do so this summer.

- Among those who normally use a playfield or public park for sports or other physical activity, the large majority (89%) intend to do so this summer. Many (78%) of those who generally use City of Calgary golf courses plan to do so this summer while around as many (74%) of those who take children to a playground will continue that behaviour this summer. The City's tennis and pickleball courts plan to be used by only two-thirds (67%) of those who normally use them.
 - More males than females (93% vs. 84%) plan to use a playfield or public park for sports or other physical activity this summer.
 - Fewer seniors (aged 65 years or older) than other Calgarians plan to use a playfield or public park for sports or other physical activity this summer (74% vs. 91% 18 34 and 90% 35 64).
 - More males than females (73% vs. 59%) plan to use City of Calgary tennis or pickleball courts this summer.
 - Those with a senior (aged 65 or older) in the home are less likely than others (52% vs. 71%) to use City of Calgary tennis or pickleball courts this summer.

Key Findings

Calgarians tend to think they're receiving good value from the property tax dollars but are split on whether The City should increase taxes or cut services in order to balance taxation and service delivery levels.


- Slightly more than one-half (54%) of Calgarians think they receive good value from their property tax dollars while one-in-five (19%) rate the value as poor.
- Calgarians' preferred approach to balancing taxation and service delivery levels hasn't changed since Snapshot 2, with nearly one-half (48%) preferring the option to increase taxes (mostly the option to increase at the current inflation rate to maintain current service levels). Around as many (44%) prefer The City cuts services to either maintain the current tax level or to reduce taxes.
 - More males than females think The City should cut services further in order to reduce taxes (23% vs. 16%).
 - Those aged 18 to 34 years are more likely than older Calgarians to opt for increasing taxes (60% vs. 42% 35 64 and 44% 65+).












Trust In The City's COVID-19 Response




Perceived Threat Level of COVID-19






Stress Level When in Public During the Pandemic





Change in Mental Health Between From Just Before the Pandemic to Before Lifting of Restrictions on May 25




Changes in Personal Financial Situation








Financial Impacts of COVID-19 Pandemic

The negative financial impacts of the pandemic on Calgarians has remained relatively consistent across the three Snapshots with two exceptions. 

(among homeowners with mortgage payments)








Proportion of Rent Payment Paid in Current Month (among renters)








Support for Mandatory Face Masks



Prioritizing Public Health vs. Economy






Intention to Use Outdoor Recreation Areas














Quadrant of Residence






