* Comments - please refrain from providing personal information in this field (maximum 2500 characters) As a family physician working in low-income community health centres, I think it's a matter of equity that we determine mandatory masking is safest for our communities. When I'm at stores, salesclerks are at risk. For those on transit, drivers are at risk. These essential workers should not be putting their lives on the line when there are simple mitigation strategies we are not employing. Very few people would require an exemption (my most anxious patients are anxious about a lack of masks, not having to wear one, and those with lung disease need to be protected the most). We would not need to enforce it punitively, as demonstrated by the east in ON with high uptake as soon as mandating was passed. In Calgary, transmission rates are rising, which actually reflects the truth from a week ago. It's time to protect your citizens. You have the legal right to do so, and you can see for yourself we are nowhere near the 80% uptake required.
