**Mandate:** To make recommendations to City Council through the SPC on Community & Protective Services on policy and systems issues impacting people with disabilities. To be a resource to City Council and City Administration in addressing physical, transportation, communication, social and economic accessibility issues to provide a high level of accessibility for people with physical, sensory and cognitive disabilities.

**Composition:** 6 Members with disabilities representing a range of people with physical, sensory and cognitive disabilities  
1 Member representing the seniors community  
3 Citizens-at-Large who may or may not have a disability, but who are interested in access issues  
3 Members of City Administration (e.g., Planning and Development, Calgary Transit, and Calgary Recreation)
