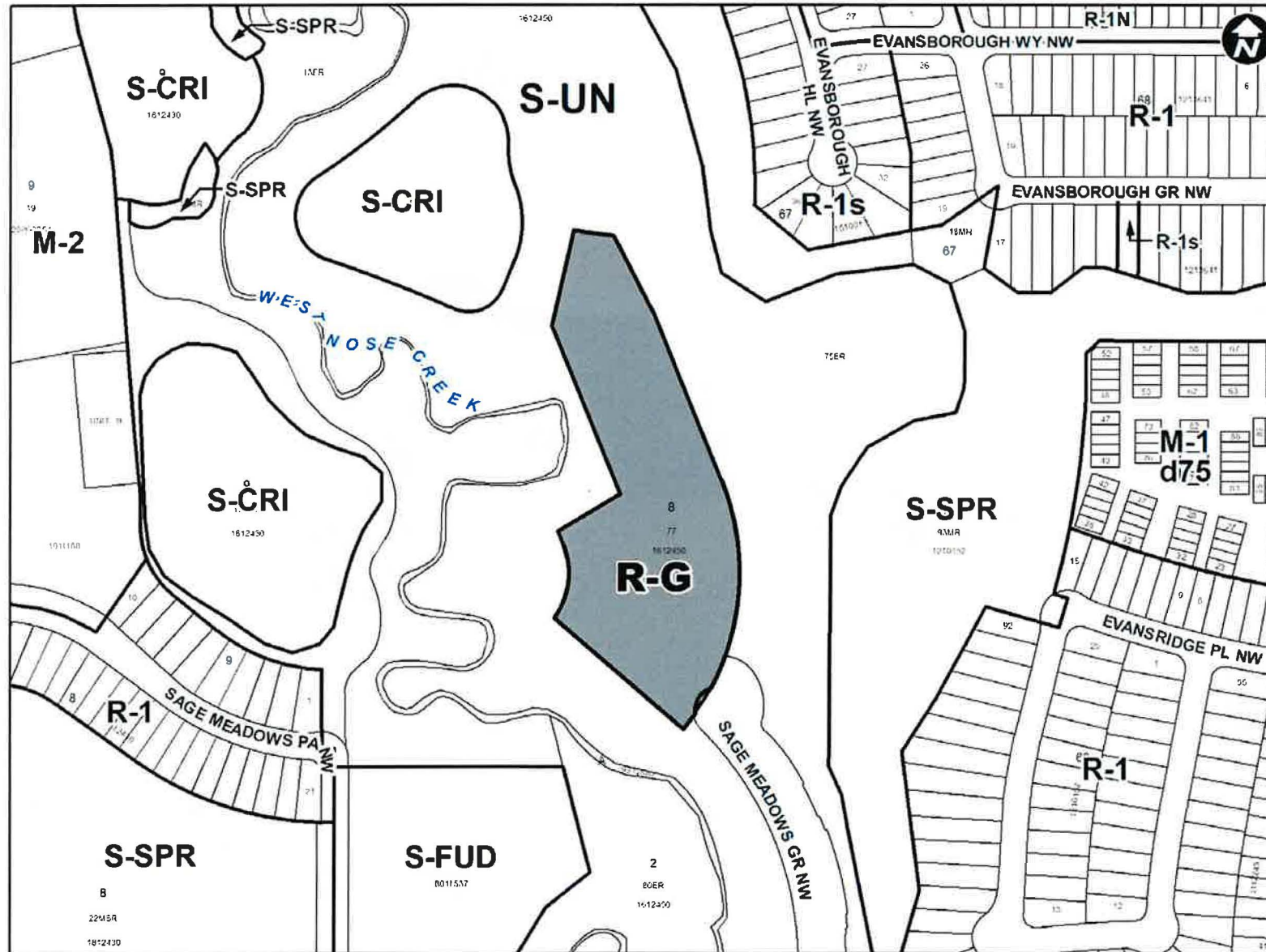




Existing land use:

- Maximum of 127 units could be accommodated on the site

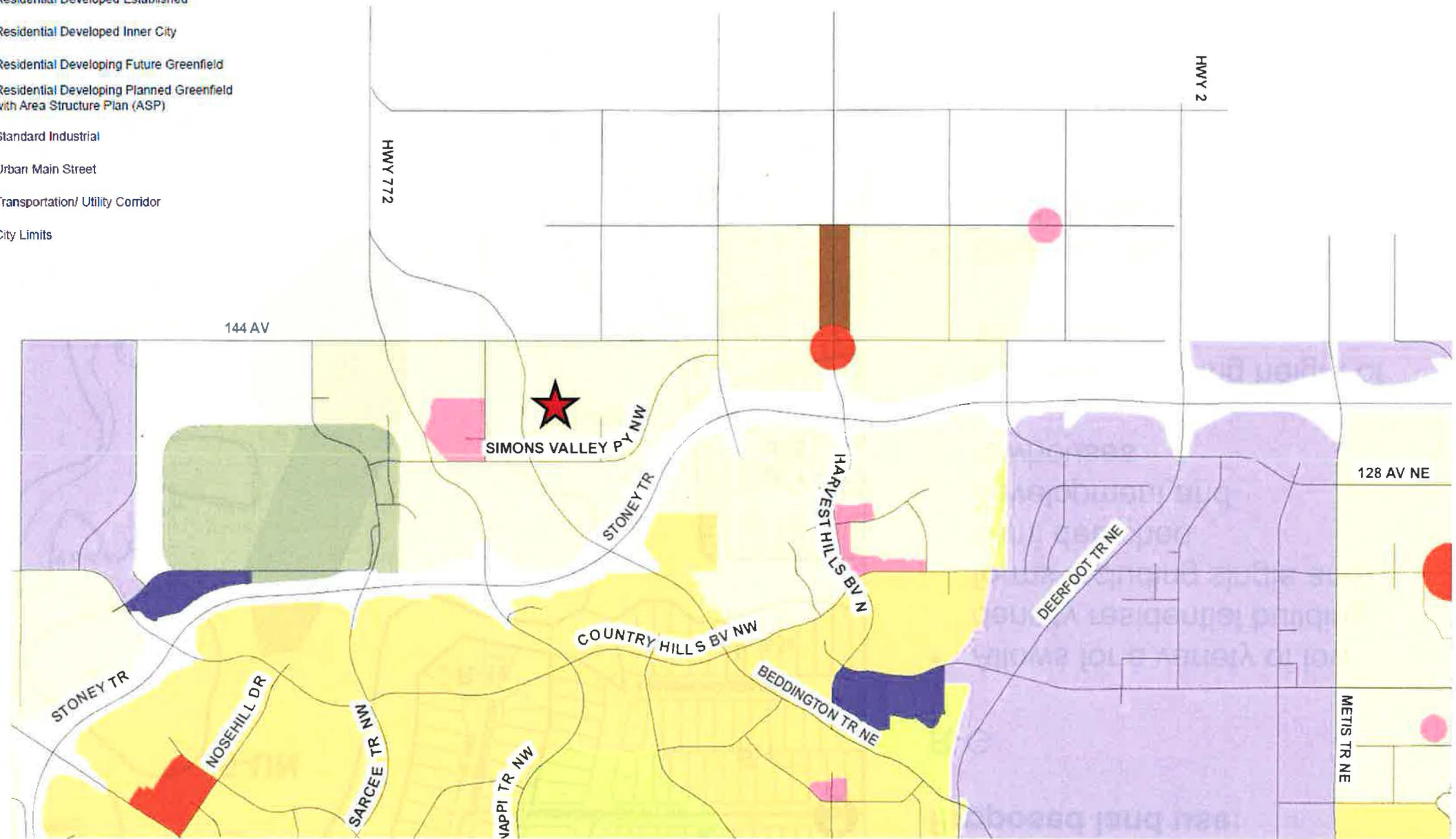


Proposed land use:

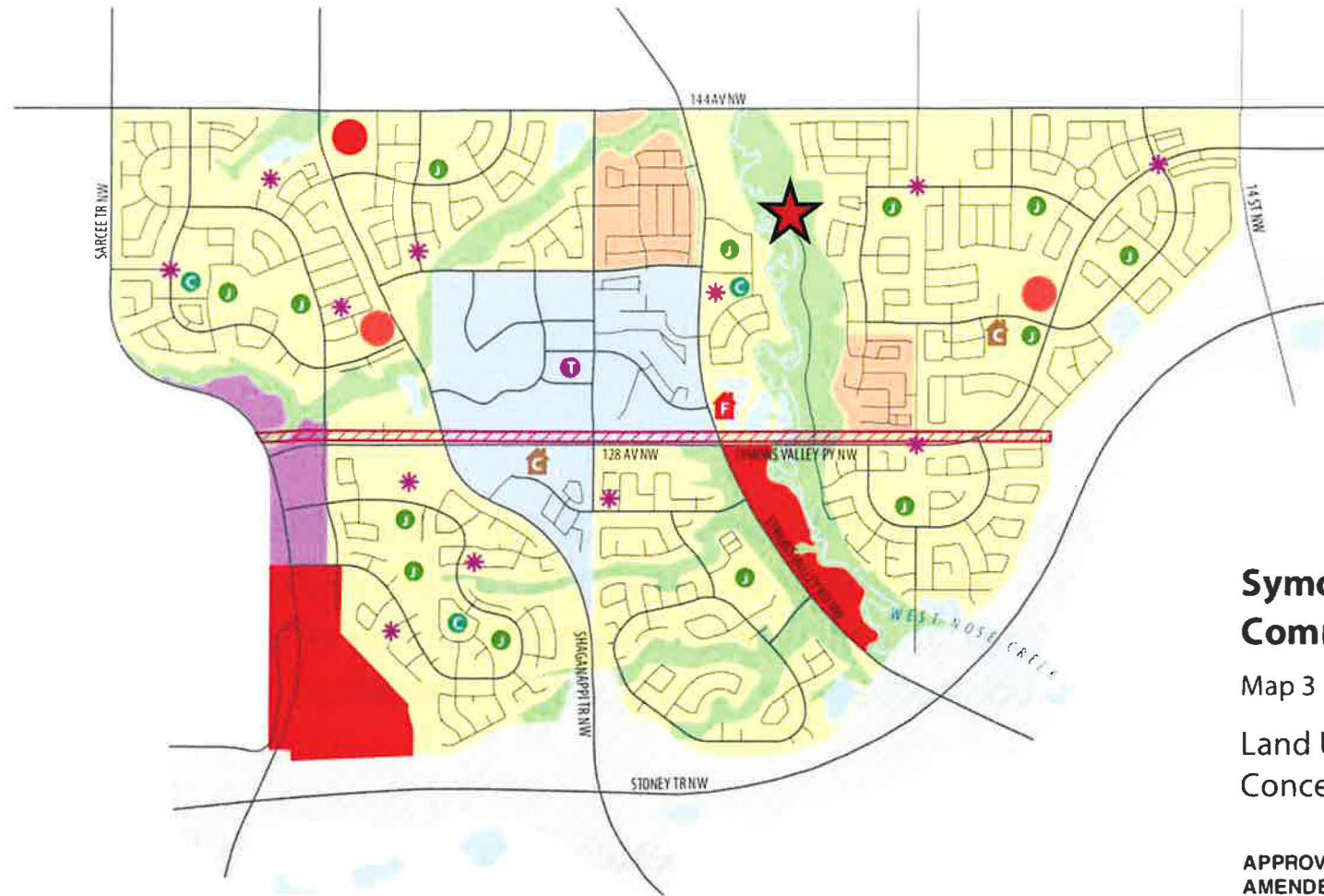
R-G

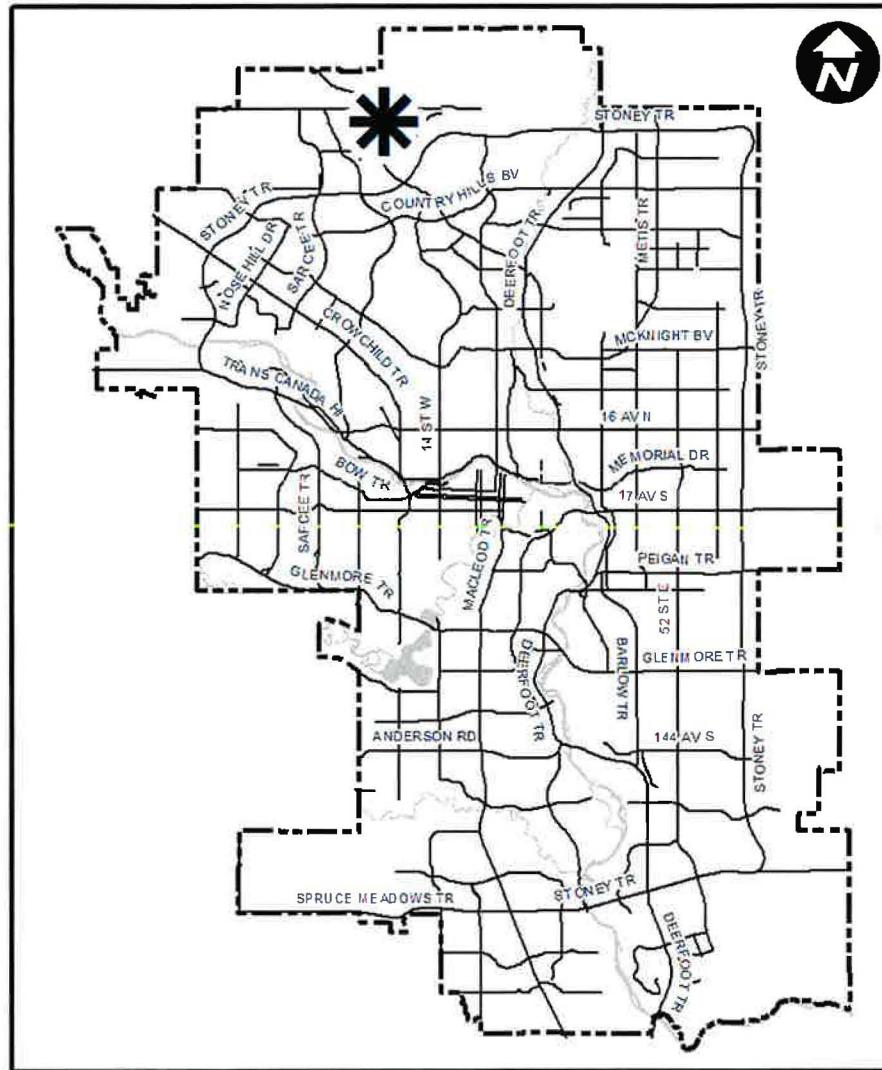
