- Commemoration, to increase public awareness of the historic significance of the streets and to build an intrinsic value among the citizens of Calgary for the trees and the streets.

Trees are an important part of what not only makes older neighbourhoods more beautiful, but are a reminder of our history (William Reader's plans for example). To see a stronger sense of protection for our tree canopy, would the City consider adopting a bylaw similar to what Vancouver has done with their Bylaw 9958? This bylaw aims to protect trees on private property (If you want to remove a tree on your property, you need a tree removal permit for every tree that has a diameter (width) of 20 cm or greater, measured at 1.4 m above the ground).

Thank you for reaching out to our community and including Scarboro within your award winning plan. Congratulations on the receiving the MUDA award. We fully support your initiative and any City of Calgary and/ or broader community initiative that speaks to the Garden Community aesthetic of Scarboro and that strives to preserve it.

While Senlac, Sharon and Shelbourne are ideal street-scapes we believe that there are additional roads to be included within your scope, identifying historic streets in Calgary. Please consider discussing the full scope and broad array of historic streets in Scarboro with us, as we could have identified all of the streets that would fall within the criteria of the 27 already identified. The extracted pages from your report concerning Scarboro identify a number of trees that are in fact flourishing and in our belief, should not be subject to replacement simply for a restorative operation to the original street-scape arbour. We would like to have a discussion around each individual tree that on the report is earmarked for replacement.
