2021 Spring Pulse Survey


This survey is an important tool in understanding citizens' overall perceptions
of, and satisfaction with, The City of Calgary. Topics include: Quality of life in
Calgary, top issues facing the city, City programs and services, value of
taxes, City reputation, and City performance.

2021 Economic Perspectives Survey (Q1)

 This survey measures citizens' perceptions about the current economy, quality of life, and other aspects of the economy as well as perspectives on City infrastructure spending.

COVID-19 Snapshots

 Since the onset of the COVID-19 pandemic, The City has been running recurrent surveys about the impacts of the COVID-19 pandemic on Calgarians to help inform the pandemic response.





Methodology

2021 Spring Pulse Survey

- Telephone survey n=2,500
- March 1 22, 2021
- Topics include: Quality of life in Calgary, top issues facing the city, satisfaction levels with a range of City services, value of taxes, City reputation and performance.

Economic Perspectives 2021 Q1

- Telephone survey n=500
- April 6 14, 2021
- Topics include: State of the current economy, economic outlook, quality of life, and perspectives on City infrastructure spending.











that is, the one issue you feel should receive the greatest attention from your local leaders?








Tracking Perceived Value of Taxes












Importance vs. Satisfaction Grid







Perceptions of City Performance











Face Coverings Bylaw Enforcement


Support of Face Coverings Bylaw

Agreement with Level of Enforcement of Face Coverings Bylaw




To what extent do you agree or disagree that The City is sufficiently enforcing the Face Coverings Bylaw?
