PREVIOUS COUNCIL DIRECTION / POLICY

On 2015 November 9, Council adopted NM2015-26 (Damage To Public Property During Construction) and directed Administration to "explore the following and other options to reduce the amount of public property damage during construction and improve cost recovery, with a report back to the Standing Policy Committee on Transportation and Transit no later than September 2016:

- Improve pre- and post-construction inspections and documentation during the construction of private property in order to measure third-party public property damage to ensure recoveries through a Property Damage Occurrence Report;
- Staff training and cooperative support from City departments and partner agencies including Calgary Parking Authority, Parks, Calgary Community Standards, Calgary Transit, Alberta Road Builders and Heavy Construction Association and other stakeholders to report damage and ensure that best practices are being understood, and applied."

BACKGROUND

Contained within the road right-of-way, The City of Calgary is responsible to maintain a number of valuable assets, including catch basins, curb and gutters, fences, laneways, manholes, noise attenuation walls, pavement surface, sidewalks, streetlights, traffic control devices and trees. These assets are sometimes damaged due to accidents, negligence or deliberate acts by a third party. The Alberta Building Code, as well as The City's municipal bylaws including the Street bylaw (20M88) and Tree Protection bylaw (23M2002), contains language that supports enforcement and assigns responsibility of third party damages back to the party responsible.
