- COVID safety protocols are in place for all work sites.





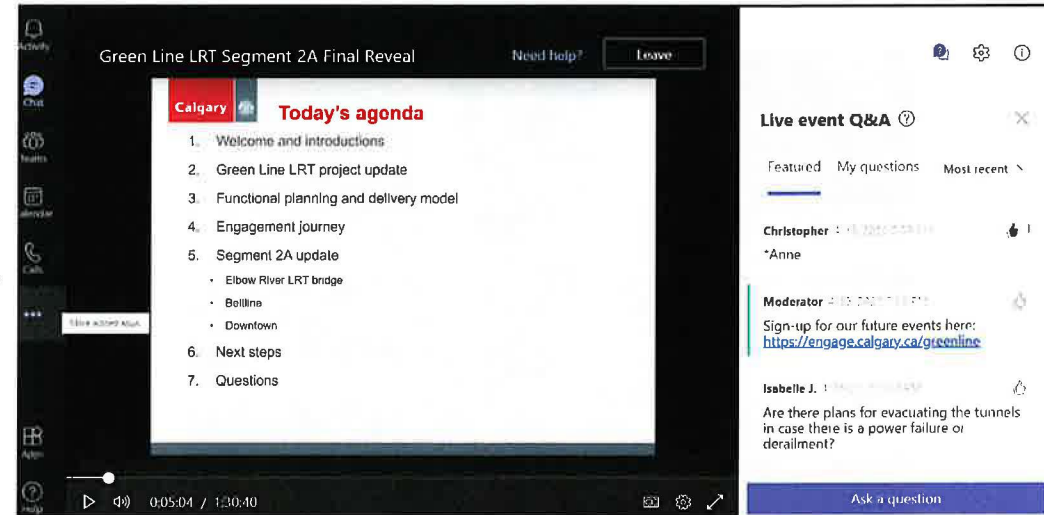
- Baseline data for contaminated sites, biophysical and fisheries, trees, noise, greenhouse gases and soils
- Highfield Landfill received a certificate of remediation, making it the first landfill in the province to receive such certification





Stakeholder Relations

- Work with the province is progressing
- Ongoing project uncertainty and lack of clarity in schedule and timelines continues to impact other project stakeholders
- Segment 2 Functional Plan engagement activities through April 2021 provided an opportunity for broader public communication



- Lack of clarity in schedule will continue until completion of provincial review
- Schedule to be updated once provincial review is completed
- Opportunities are being identified to further reduce overall risk



- \$16.4M spent in 2021
- Every 0.5% increase in escalation = More than \$100M to GL budget
- Board has requested all cost estimates to be at P90
- Key drivers to cost are Escalation, Schedule and Borrowing
- Following Approved Council Stage Gate Approach





- Focus has been on oversight of Segment 1 Enabling Works contracts
- A Quality Management Plan for the entire project is being developed
