# Pathways and Bikeways Project Steering Committee – Disbandment

#### **RECOMMENDATION:**

That Council disband the Pathways and Bikeways Project Steering Committee and thank its members for their service.

#### **HIGHLIGHTS**

- The City Clerk's Office received confirmation that the mandate of the Pathways and Bikeways Project Steering Committee ("the Steering Committee") is completed.
- The Steering Committee was established to assist the Pathways and Bikeways project team by reviewing progress and deliverables and providing strategic input into an updated pathway and bikeway plan with City-wide and regional connections planned for the next 20 years.
- What does this mean to Calgarians? The Steering Committee provided oversight on the progress and deliverables of the plan, ensuring that the plan reflects the priorities and interests of current and future users.
- Why does it matter? Disbanding the Steering Committee in a timely fashion contributes to the efficient use of the City's resources.
- Strategic Alignment to Council's Citizen Priorities: A well-run city
- The annual update of the Steering Committee (2020 June 15 Council, C2020-0474) is included as Attachment 1.

#### **DISCUSSION**

The Steering Committee presented its annual update at the Special Meeting of Council RE: Boards, Commissions and Committees on 2020 June 15. The Chair of the Steering Committee indicated at that time that the Steering Committee would remain in place until the adoption of Next20, the Municipal Development Plan & Calgary Transportation Plan review.
