### Presentation to the Advisory Committee on Accessibility

The Advisory Committee on Accessibility is a Municipal Citizen Committee that provides access recommendations to City staff and Council on the rights and service needs of Calgarians with disabilities.

On 2016 June 06 Facility Management and Calgary Growth Strategies gave a joint presentation on the Motion, providing an Administrative update and requesting subject matter expertise on accessibility. An invitation was also extended to committee members interested in participating in the Planning & Development Technical Advisory Committee on Accessibility.

#### **Industry Engagement**

A roundtable accessibility discussion, organized by Ward 7 Councillor, was held on 2016 June 16. This meeting included the Ward 7 Councillor, people with user experience, industry members, non-profit organizations, and City staff. This discussion focused on Planning & Development scoping options for accessible housing and universal design. Subsequent meetings were held between City staff, people with user experience, and the development industry on 2016 June 30 and 2016 July 6.

Communication with the Calgary Home Builders Association – Urban Development Institute (CHBA-UDI) commenced in June, 2016. A meeting was held 2016 August 10 to discuss project scoping, implementation, and accessibility from a developer perspective. Implementation work has been, and will continue to be, circulated to CHBA-UDI as part of the larger planning initiatives (MDP Guidebooks and Urban Design Guidelines circulations).

A mail-out to the Established Areas and Phasing Growth/Land Supply Industry/City Workplan Groups was delivered 2016 August 18. This communication was intended to update industry on work-to-date, to inform project scoping, and to invite interested members to become involved.
