EXECUTIVE SUMMARY

The trustees of the Wild Rose United Church (North Hill Presbyterian Church) have requested designation of the property as a Municipal Historic Resource under Section 26 of the Alberta Historical Resources Act.

The Wild Rose United Church (North Hill Presbyterian Church) is a Gothic Revival-style structure built in 1929 and located in the Crescent Heights community. The property has been determined to be significant by the Calgary Heritage Authority, for its institutional value, being home to a large congregation and its associated organizations since 1914; its stylistic value, being an understated but distinct example of Gothic Revival style architecture in the community; and, its landmark value, being one of the most substantial historic buildings in the community with a prominent corner location and distinctive architecture.

ADMINISTRATION RECOMMENDATION(S)

That the SPC on Planning and Urban Development recommends that Council give three readings to the proposed bylaw to designate the Wild Rose United Church (North Hill Presbyterian Church) as a Municipal Historic Resource.

BACKGROUND

The Wild Rose United Church (North Hill Presbyterian Church) (address: 1317 First St. N.W.; short legal description: Block 3946N; Plan 8; Lots 9 & 10) was added to Calgary's Inventory of Evaluated Historic Resources in 2016 as a property of "Community" significance. The property has been determined to be significant by the Calgary Heritage Authority, for its:

- Institutional value, being home to a large congregation and its associated organizations since 1914.
- Stylistic value, being an understated but distinct example of Gothic Revival style architecture in the community.
- Landmark value, being one of the most substantial historic buildings in the community with a prominent corner location and distinctive architecture.

The property owner has requested designation of the property as a Municipal Historic Resource (as outlined in Attachment 1 to this report) to protect the property in perpetuity and to make the property eligible for conservation grant funding from the Alberta Historical Resources Foundation and City of Calgary Conservation Grant Programs.

INVESTIGATION: ALTERNATIVES AND ANALYSIS

Designation of the Wild Rose United Church (North Hill Presbyterian Church) legally protects the property and ensures that any future changes and conservation work aligns with best practices in heritage conservation. The proposed bylaw (Attachment1) identifies the elements of the property that contribute to its heritage value and must be treated appropriately in any future changes or conservation work.

Stakeholder Engagement, Research and Communication

The trustees of the Wild Rose United Church (North Hill Presbyterian Church) requested Municipal Historic Resource designation April 12, 2016. A 'Notice of Intention' to designate the property was issued April 18, 2016. The trustees of the Church are in agreement with the proposed bylaw.

Strategic Alignment

Council priorities outlined in The City's 2015 – 2018 Action Plan include the fostering of "A city of inspiring neighbourhoods". Historic resources are an integral component of such neighbourhoods and their retention contributes to the diversity and character of their surroundings.

The City of Calgary *Municipal Development Plan* supports the conservation and protection of Calgary's historic resources. The plan identifies historic preservation as part of good city building and community identity, and encourages property owners to conserve Calgary's historic resources.

The City of Calgary 2020 Sustainability Direction includes an objective for Calgary to become a "diverse and socially inclusive city that respects its heritage and the arts," as well as a strategy to "support the preservation of Calgary's historic resources."

The City's *Calgary Heritage Strategy* (2008) recommends that identified historic resources should be protected by designation bylaws, when possible, to ensure their preservation. This protection prevents demolition, provides appropriate management of physical interventions and is critical to ensuring effective management of historic resources.

Social, Environmental, Economic (External)

Social

Historic resources connect us to our past, our future, and to each other. They provide places of learning and places of understanding for all Canadians.

Historic resources are integral to the identity of our community and help to strengthen its distinctiveness. Historic resources add to the beauty, character and visual interest of our urban environment which contributes to the city's liveability and are sources of community pride.

Environmental

The preservation of historic places capitalizes on their embedded (embodied) energy – the sum of all resources and materials that were originally incorporated in the development of the place and which would not have to be produced again for the development of a new place.

Economic (External)

The property adds character and visual interest to the streetscape which makes economic investment in the area an attractive prospect. Designation will ensure these attributes are protected and the resulting security will promote high-quality investment. Also, tourists and residents are attracted to areas with historic resources.

Financial Capacity

Current and Future Operating Budget:

Designation of the Wild Rose United Church (North Hill Presbyterian Church) will have no operating budget implications for The City of Calgary.

Current and Future Capital Budget:

Designation of the Wild Rose United Church (North Hill Presbyterian Church) will have no capital budget implications for The City of Calgary.

Risk Assessment

No risks have been identified in designating the Wild Rose United Church (North Hill Presbyterian Church) as a Municipal Historical Resource.

REASON(S) FOR RECOMMENDATION(S):

The property is identified on Calgary's Inventory of Evaluated Historic Resources, as a site of 'Community Significance', making it eligible for designation as a Municipal Historic Resource. The trustees of the property have formally requested designation. Protecting Calgary's historic resources is an identified objective of The City.
