We are writing in regard to the proposed redevelopment by Anthem Properties, located at 1724 Westmount Boulevard NW (the former CBC site). Please accept this letter in support of their application.

Our company operates out of the Hillhurst area; since 2014 we were located at 2120 Kensington Road NW and more recently our office has moved a short distance to 1422 Kensington Road NW. This location puts us in very close proximity (historically and currently) to the site location of this project. Working in the architectural industry gives great perspective on projects throughout the City, province, and beyond. We review this project to be very appropriate to the community context and a strong example that follows best practise in our industry.

Upon hearing the site was finally being redeveloped, we anticipated additional height and density than what is proposed with this application, as given the context it could be reasonably rationalized. This developer has alternatively chosen a product with reduced impact to the surroundings, while keeping in line with the Municipal Development Plan (MDP). The design thoughtfully interfaces with the street edges and the built form appears to be well integrated with the community.

It is noted that this parcel has sat vacant for significant time, and we commend Anthem for pursuit of this development opportunity. It is anticipated that Council approves the project. Seeing this project one step closer to a constructed reality should bring a great deal of pride not only for their team, but more notably for the greater community and the future residents of this desirable location. This work is another strong example of the commitment Anthem brings to the development table.
