BACKGROUND

The Audit Committee was established by resolution of Council on 1979 November 19. Bylaw 48M2012, as amended, being a Bylaw of the City of Calgary to Continue the Audit Committee, provides the Audit Committee's mandate and Terms of Reference. The Audit Committee's mandate, current composition, appointment term and quorum are detailed in Attachment 1.

INVESTIGATION: ALTERNATIVES AND ANALYSIS

On 2016 April 17, Rajesh Ghosh informed the Chair and Vice-Chair of the Audit Committee of his resignation. The formal letter of resignation is detailed in Attachment 2. On 2016 May 13, the City Clerk's Office was informed that Rajesh Ghosh's last day as an elector member of the Audit Committee is 2016 June 30.

Rajesh Ghosh's appointment term on the Audit Committee was set to expire at the 2017 Organizational Meeting of Council. Following the resignation, there will be two elector members remaining on the Audit Committee. The Chair of the Audit Committee is recommending that the vacant position remain until the 2016 Organizational Meeting of Council. As per Bylaw 48M2012, as amended, the Audit Committee may continue to operate and conduct business until vacancies are filled provided that the quorum requirement is met. The quorum of the Audit Committee is four members, comprised of one elector member and three Members of Council.

Stakeholder Engagement, Research and Communication

The City Clerk's Office consulted with the Executive Assistant of the Audit Committee, and has been advised that the Chair of the Audit Committee would like the vacant position to remain until the 2016 Organizational Meeting of Council.
