## Foothills Athletic Park Redevelopment Advisory Committee – Amended Terms of Reference

---

### RECOMMENDATION(S):

That Council adopt the amended Terms of Reference for the Foothills Athletic Park Development Assessment Committee contained in Attachment 1

### HIGHLIGHTS

- Foothills Athletic Park and the McMahon Stadium Lands have historically had a regional and citywide draw for sporting and recreational events
- Tourism Calgary continues to work with the City to attract sport tourism to the city and the redevelopment of Foothills Athletic Park. Their involvement in FAPRAC will provide valuable insight in the development of the future recreational amenities and the opportunity to expand the city's offering in new sport and recreation facilities.
- On 2019 February 25, Council approved the Foothills Athletic Park Redevelopment Advisory Committee Terms of Reference (C2019-0274), and a minor amendment was adopted on 2020 June 15 (FRA2020-0606).
- Strategic Alignment to Council's Citizen Priorities: A well-run city

### DISCUSSION

Since the Terms of Reference for the Foothill Athletic Park Redevelopment Advisory Committee (FAPRAC) was approved on 2019 February 25, several committee meetings and working group meetings have been held. FAPRAC has overseen the preparation of a concept plan for the Foothills Athletic Park and McMahon Stadium Lands in partnership with the University of Calgary that includes the future site of a planned Field House and adjacent recreational, commercial and residential lands. A report describing this concept plan will be presented to Council in Q3 2021.

This report is recommending that a representative from Tourism Calgary be added to FAPRAC to provide additional insight to the committee given that Foothills Athletic Park, McMahon Stadium and the surrounding businesses are drivers of and beneficiaries of tourism in Calgary. Tourism Calgary is well positioned as a civic partner to offer FAPRAC their expertise to provide additional insight, particularly into sport tourism needs and opportunities that the redevelopment of the overall lands can look to capitalize on in the future.
