Re: Input for Crescent Road - Today and Tomorrow Agenda Item

As a long-time resident of Crescent Heights, I want to advise you of the negative impact of the Crescent Road Closure to residents living nearby the closed road.

From my home at the corner of 7 Ave NW and Centre A St NW I am seeing and experiencing a dramatic increase of the following while Crescent Rd is closed:

- Centre A St NW between 7 Ave NW and Crescent Rd has become a very busy street with vehicles travelling at high speeds as they move both to and from the 100 block of Crescent Rd:
- 7 Ave NW is a very busy street with vehicles entering from and leaving to Centre Street;
- cars frequently rev their engines, brake hard and accelerate from the stop sign at Centre A Street onto 7 Ave NW in both directions:
- afternoons, evenings, and weekends, when it is not raining, we are not able to sit in our back yard nor front yard and have a conversation nor are we able to sleep with windows open because of the noise from the many fast travelling vehicles, specifically the cars with tuned mufflers, the loud music being emitted from cars, and the loud motorcycles.

Quite frankly, the current situation is not tolerable.

If any portion of Crescent Road is to be closed permanently then the impact to the adjacent streets must be considered, and work done to ensure that the Crescent Rd issues are not simply moved elsewhere in the community. The permanent closure of the residential Avenues at Centre Street could address the issues that have moved from Crescent Rd.

Also, it is not at all clear where motorists from outside of Crescent Heights wanting to visit Crescent Park or to enjoy the 'promenade' created by the Crescent Road closure are to park. No parking signs have been placed all around the park and on all streets perpendicular to the closed road. Shamefully there is not even handicap parking. Once again, the burden is pushed to the neighbouring residential streets.

As work/ design continues to address the issues on Crescent Road, it is paramount that you ensure that changes benefit the entire Crescent Heights community and make a welcoming destination for all Calgarians and tourists to enjoy. With this year's closure, the primary benefactors from the road closure are the residents in the 200 and 400 blocks of Crescent Road, as well as in the 700 block of 2 St NW. And it is at significant cost to their nearby neighbours.

"My wife and I reside on the 500 block of Crescent Road NW. I have a history on this street dating back to 1962 as I grew up in the house we now own. We support the current closure of the portion of the road east of 4th St. NE as, so far, it has largely resolved the racing cars and motorcycles, tailgate parties and drug deals that were causing a major disturbance to the residents of our 500 block. While initially concerned that not closing the 500 block would simply amplify our problem, the closure effected to the east of us has greatly reduced the problems and we are again seeing pedestrians, cyclists and children enjoying the promenade instead of the problems. We are hopeful that this will continue and that further measures may not require road closures in our block as well. To the extent that more controls are required, perhaps resident parking zones might be implemented as they once were. I believe that my neighbours in the 500 block are very willing to engage in support of a process to find the right answer. I would have liked to speak to this in person at the meeting but unfortunately will be out of town when it takes place. Our thanks to the City and in particular Ms. Glowacz for her continuing work on these issues.

I believe Crescent Road belongs to all of the City of Calgary to enjoy. HOWEVER, the disruptive, illegal and dangerous behaviour that occurs either on Crescent Road, or roads leading to it has made peace and safety a concern for the residents that live in the area. The parties and loud cars in the wee hours of the morning are concerning whereby our family must move to the basement to sleep, or wear earplugs. Litter such as discarded liquor bottles and cannabis canisters around the neighbourhood also point to consumption in our residential area and oftentimes, our family witnesses parked cars full of individuals consuming such items prior to driving away. The most concerning issue for our young family are the speeding, or often, racing vehicles either on Crescent Road, or on surrounding roads leading to it. The park is accessed by many families and there have been several instances of 'near miss' pedestrian or bicycle accidents by speeding vehicles or motorcycles. The current closure of Crescent Road has reduced all of the peace and safety concerns listed above. Crescent Road draws many vehicles to the area; notwithstanding whether the road is open to vehicles or closed to vehicles. To ensure the safety of all users (vehicles, pedestrians and bicycles), traffic calming measures are a necessity. There are too many speeding vehicles/motorcylces and no enforcement of the speed limits. There have been too many 'near miss' accidents including cars, bicycles and pedestrians due to speed or reckless driving (stunting). Speed bumps, increased stop signs etc would be a first step. Whether Crescent Road is open to vehicles or closed to vehicles, there are impacts to surrounding avenues and streets, including speeding and illegal parking. A full traffic study would likely indicate the need for traffic calming on Crescent Road and many avenues and streets that lead to Crescent Road.

The traffic issue of Rosedale and Crescent Heights should be studied at length before any permanent changes are made to Crescent Road NW. It would be foolhardy to close Crescent Road NW permanently without addressing the traffic issues through the entire community. The current closure of Crescent Road NW has put more pressure on Alexander Cres. NW. The city should be directing traffic onto 13th Avenue NW which is the main conduit through the community. As a result, we do NOT support the closure of Crescent Road NW permanently. The closing of one road pushes the problem of increased traffic onto other roads. Alexander Crescent NW residents have experienced a substantial increase in traffic from residents and visitors who formerly use Crescent Road. Because of the closure of Crescent Road, Alexander Crescent has more vehicular traffic, more loud motorcycle traffic and more vehicles travelling at unsafe speeds. While Crescent Road NW residents benefit from substantial no traffic noise during the temporary closure, Alexander Cres NW residents (our street run parallel to Crescent Road) have to deal with an inordinate amount of increased traffic. This has substantial decreased our enjoyment of the outdoor use of our yards and property due to increased noise, exhaust and unsafe speeds of drivers. Dear Members of Council,

Thank you for this opportunity to submit our views. As long time (25+ yr.) residents of Crescent Heights, we live a few blocks north of Crescent Road. In pleasant weather, we visit the road virtually every day, walking or biking, and over the winter months we enjoy strolling, when possible, or taking in the city view/lights from our vehicle.

We wish to please express our **support for:** 1) <u>re-opening all of Crescent Road for vehicles</u> with the exception of perhaps one thoughtfully selected block - reserved and designed for special (community and beyond) events/activations. 2) A thoughtful, easy-access parking plan designed to accommodate visitors. 3) A plan to address issues of disrespectful/unlawful behaviour, employing alternatives (to closure) *such as* increased bylaw /police officer and security presence, monitored CCTV, and on-the-spot ticketing... this, while educating, and enabling an accessible, fun, safe and family-friendly space.

Crescent Road is an absolute treasure; With access to the bluffs, the amazing skyline and lights - it encourages citizens from all over the city to connect, spend time outdoors, and create priceless memories. It is only fair to acknowledge that, as local residents, we do not have exclusive ownership over this road. While a public attraction of this kind is also, unfortunately, bound to attract some troublesome behaviour - we support finding ways to address these difficulties without having to impose restrictions that unfairly deny access for the good majority.

We respect that this closure briefly served a pandemic-distancing function, however it seems to have been quickly re-imposed as a solution to deal with the aforementioned bad behaviour. We would like to please assert that blocking the road - and erecting barriers at the entrance to every access street - is very prohibitive and punitive to the public at large and does nothing to specifically deal with resident complaints (noise, littering, speeding, lawlessness) only pushing these issues elsewhere while creating new problems of parking and access.

Those in favour of permanent closure may argue that a closed road becomes a "place where individuals and families from all around can enjoy a peaceful stroll," yet in reality - this experience isn't readily available to those outside our immediate community, given the numerous no-parking signs that seem to have eliminated the few previously available parking zones. We've watched folks in vehicles struggle as they seek a way to approach,

only to give up and drive away. It doesn't take much imagination to recognize that gaining close access is awkward or impossible for the elderly or anyone with mobility challenges.

While strolling and biking to Crescent Road is obviously an attractive option (in fair weather -for those who are able) it is not reasonable to expect this in the colder months, especially with ice underfoot. As example, one major pathway providing access (west of the Crescent Heights High School and parking lot) is rarely shovelled and frequently treacherous. Enjoying Crescent Road during the winter, often therefore requires vehicle access. If closed (entirely) over the winter months, the road could potentially become a dismal, desolate place - not to mention, skyline/holiday light viewing (an annual tradition for many) would be reserved for the select few who live on, or very close to the road.

Lastly, the idea of partial closure - for example, the one block running south of the park - might serve as a 'middle way' through this contentious issue. Pandemic-permitting, our very vibrant community association (CHCA) could activate a variety of appealing and exciting events on - or near - this stretch of road. Perhaps before making anything permanent, this could be tested during a series of weekend block closures. It would be important to take into consideration that when open, this particular stretch of Crescent Road, typically enables 2 hour parking for approx. 30 or more vehicles. Therefore it would be important to relocate this parking availability nearby, so that people outside the immediate area are able to gain easy access. Some overall advantages: Having one block closed might naturally slow vehicle traffic by re-routing. It would allow a place for folks to gather and stroll in peace without residents unfairly laying claim to the entire road. Events designed to selectively attract more people to the area, as well as bringing more 'eyes' to the area, may also help us procure the patrolling /policing measures required for the entire length of road.

In closing, if we have learned anything from this pandemic - it is the need for us to overcome any self-serving inclinations and to operate instead, from a place of generosity and interconnectedness. Let's please continue to openly share this city jewel with our fellow-citizens as we press for solutions to help minimize troublesome and/or illegal behaviour.

I am a resident of Crescent Heights and live close to Crescent Road. I have always enjoyed the views, access to the park and pathways that living in the area provides. I enjoy seeing the fitness activities and photo taking that fellow Calgarians enjoy in the area as well. The concern is that the area has given priority to cars over pedestrians and positive recreation. Crescent Road has become a gathering place for late night parties, racing along the bluff and a host of other negative behaviours which leaves any other Calgarians trying to use the area uncomfortable and some of the residents fearful, with concerns about their safety. Residents have been desperately trying to have additional police presence and parking enforcement to help reduce the negative behaviour with limited to no success. Something needs to be done to permanently reduce the negative behaviour and priority given to cars, while continuing to allow Calgarians to access the park and bluff for positive activities. By closing Crescent Road, our neighbourhood seems to collectively breathe a sign of relief through the reduction of the late night racing and parking directly on the ridge. Children and families enjoy strolling the ridge and using the road for positive recreation. The challenge is that a) we still need designated parking for people to enjoy the bluff and park b) cars continue to park throughout the night at all of the closure points with no enforcement or regular police presence to move late night parties along c) there is no clear traffic flow. My recommendation is to extend Crescent Park to the bluff (b/w 2St & 3st), which would increase our park footprint and green space and stop the negative behaviour that comes with "driving the ridge". It would create a beautiful pedestrian focused park where families and those interested in seeing the views and participating in positive
