

Guide for Local Area Planning Policy Overview

The following table identifies sections and policies from the Guide for Local Area Planning (Guide) that have been incorporated into the North Hill Communities Local Area Plan (Plan). As the Guide has been accepted as an Administrative Guide by Council, all required policies from the Guide that were previously referred to by the Plan must be incorporated due to the statutory nature of the Plan. Policies that do not apply, such as direction for how a local area plan identifies an urban form category, have not been included.

Adjustments were made by Administration to section and policy numbering as well as minor text revisions to ensure the Guide content fit into the Plan. These revisions do not alter the intent of the policies that have been incorporated from the Guide.
