<p>Planning and the AVPA Team have been extensively consulted throughout this work.</p>
<b>Procedural (Including reasons for confidentiality)</b>
<p>Providing the amendment allows the YWCA Calgary to further enhance their case regarding the amendment being requested by the Minister of Municipal Affairs.</p>
<b>Other Considerations</b>
<p>On 2020 September 02, Administration presented a report (PUD2020-0968) to Planning and Urban and Development (PUD) committee, recommending Council approve by resolution the proposed Calgary International Airport Vicinity Protection Area Regulation (AVPA) changes.</p> <p>On 2020 September 14, Council approved a resolution to request changes to the NEF contours, which would have the effect of removing the prohibition on Residences on the parcel of land at 2003-16 ST SE, but this request is still being considered by the Minister of Municipal Affairs and is currently pending decision.</p>
<b>Urgency Rationale</b>
<p>I am recommending this Notice of Motion be forwarded to the 2021 July 26 Combined meeting of Council for the following reasons:</p> <ul style="list-style-type: none"><li>- This expedites the decision to allow for communication with the Province on this requested AVPA regulation amendment in a timely fashion;</li><li>- The not-for-profit agency YW Sheriff King Home, currently has an active development permit application being reviewed by Administration. However, decision cannot be rendered until the AVPA amendment has been considered by the Minister of Municipal Affairs.</li><li>- The applicant would like to seek approval of their emergency shelter and affordable housing development project as soon as possible, and have the opportunity to capture the federal Rapid Housing Initiative funding available.</li><li>- Council's decision to support the amendment will better inform the Minister of Municipal Affairs' decision regarding the AVPA exemption for Residential Use at</li></ul>
