BYLAW NUMBER 29P2016

BEING A BYLAW OF THE CITY OF CALGARY TO AMEND THE LAND USE BYLAW 1P2007

WHEREAS it is desirable to amend the Land Use Bylaw 1P2007, as amended;

AND WHEREAS Council has held a public hearing as required by Section 692 of the Municipal Government Act, R.S.A. 2000, c.M-26, as amended:

NOW, THEREFORE, THE COUNCIL OF THE CITY OF CALGARY ENACTS AS FOLLOWS:

- 1. The City of Calgary Land Use Bylaw, being Bylaw 1P2007 of the City of Calgary, as amended, is hereby further amended as follows:
 - (a) Add a new subsection (q.1) to section 954(2):
 - "(q.1) Protective and Emergency Service,"
 - (b) Delete and replace the wording in subsection 150(a)(i) with:
 - "(a)(i) where motor vehicles with a **gross vehicle weight** equal to or less than 4536 kilograms are serviced and repaired in a **building**; and"
 - (c) Delete and replace the wording in subsection 151(a)(i) with:
 - "(a)(i) where motor vehicles with a **gross vehicle weight** equal to or less than 4536 knograms are serviced and repaired in a **building**; and"
